SBI EMPLOYEES PENSION FUND RULES / REGULATIONS IMPORTANT THINGS TO KNOW

A. PENSIONABLE SERVICE:

The service rendered by an employee from the date of his admission to the fund upto the date of retirement shall be reckoned as service for pension.

Note-1: The period of leave granted without leave salary, or the period of absence without leave shall not count as pensionable service.

Note-2: The period of suspension shall count as pensionable service, only to such extent as the authority, which reinstates him/her, declares it to be pensionable at the time of reinstatement or the authority which sanctions his/her retirement declares it to be so at the time of according the sanction.

B. RETIREMENT ON MEDICAL GROUNDS:

A member who shall be proved to the satisfaction of the authority empowered to sanction his retirement to be permanently incapacitated by bodily or mental infirmity from further active service (such infirmity not being the result of irregular or intemperate habits) may, at the discretion of the trustees, be granted a **proportionate pension**.

C. CLARIFICATION:

- SBI Employees, who have put in 30 years or more pensionable service, as on the date of retirement, are eligible for Pension at 50% of their last 12 months' average Pay.
- SBI Employees whose pensionable service is less than 30 years as on the date of retirement will be eligible for proportionate pension as per the length of pensionable service.

D. COMPUTATION OF PENSION:

- 1. Pension payable shall be the amount calculated at the rate of one-sixtieth part of the average monthly substantive salary drawn during the last 12 months' pensionable service of every years' pensionable service.
- 2. 'Salary' or 'Substantive Salary' shall include other emoluments or such portion thereof of a member and shall rank for superannuation benefits under the rules of service applicable to the member –

Herein, '**Pay**' for the purpose of superannuation benefits shall mean, Basic Pay, Stagnation Increments, Special Pay, Graduation Pay, Professional Qualification Pay, CCA component wherever applicable, the increment component of FPP and Officiating Pay, if any.

E. CALCULATION OF AVERAGE PAY:

For calculating average monthly substantive salary drawn during the last 12 months of pensionable service, the following procedure shall be adopted.

- i. In regard to an employee who has been on leave without pay such period of leave will be ignored and a corresponding period prior thereto, with actual salary drawn, will be taken into account for computation;
- ii. In regard to an employee on leave on reduced pay (Half Pay), the scale salary i.e., what he would have drawn had he not been on reduced pay, will be taken into account instead of the actual salary drawn by him during the said period.
- iii. In regard to an employee under suspension during the last one year of his/her service, if on conclusion of the disciplinary proceedings, the period of suspension should not be reckoned as service, then the salary payable to him during the last one year's pensionable service, should be taken into account for calculating the average monthly substantive salary for the purpose.

Please also note that separate instructions are available on the computation of pension in case of employees whose period of 12 months' average substantive salary falls in two Bipartite periods.

Item No.8: Any other matter with the permission of Chair. Murali Krishna, Asst. Treasurer, who is unable to attend to the organizational work due to his domestic compulsions. **The House unanimously approved** the same.

BEWARE OF CYBER CRIME VOICE CLONING SCAM

What is voice cloning scam?

A voice cloning scam involves using artificial intelligence (AI) technology to replicate in someone's voice, typically for fraudulent purposes.

Scammers can use these clones to impersonate individuals and trick them or others into giving up personal information, transfer of money or access to accounts.

How it works:

- Voice Gathering Scammers might collect voice samples of the targeted person from various sources, like social media videos, public speeches or even intercepted phone calls.
- > These samples are used to train AI algorithms to learn and mimic the targeted person's voice patterns, intonation and speech characteristics;
- After training, the AI can generate realistic audio that sounds like the targeted person, even saying new phrases or sentences.
- > Scammers then use the cloned voice to carry out fraudulent activities such as
 - 1. **Phishing:** They call or leave voicemail messages impersonating trusted entities like Banks, Companies or even the victim's friends or family, attempting to steal personal information or money.
 - 2. **Social Engineering:** They impersonate the victim themselves to manipulate someone into taking an action, like transferring of funds or revealing sensitive details.
 - 3. **Fraudulent Orders:** They use the cloned voice to place orders or make transactions over the phone, pretending to be the real person.

In short, the voice of a person, may be your son or daughter, is cloned in the above manner and Scammers utilise that to commit frauds. You will grow wary and wondering what to do when you get a call from someone threatening to implicate your child in a criminal case if you do not meet their demands. The next minute, however, you hear your sobbing child over the phone and you fear it may be true after all.And so you pay up — only to realise later that it was, indeed, a scam.

Several such voice cloning fraud cases have surfaced in the recent past. The brief details of few of the cases are furnished for information:

Case 1: Mr. X, who works as a superintending engineer in the Municipal Corporation of Delhi, dropped his 18-year-old son at JEE mock test centre near Rajendra Nagar Metro station in Ghaziabad and then left to take care of his work.

An hour later, he got a call from a number with a '+92' country code from a caller, who claimed he was a police inspectorsaid to Mr.X that his son had been caught with a gang of rapists and demanded for payment of Rs 30,000 through **Paytm** immediately to get his son's name cleared. The caller said that Mr.X can even talk to his son. The next minute, Mr.X heard a voice saying 'Papa please pay him, they are real policemen, please save me'. Mr.X could not doubt even for a second as the style of speaking, crying and everything was the same like his son.

Despite the confusion, still suspicious, Mr.X asked the caller which police station he was posted at but the man didn't respond. Mr.X told him that he doesn't use online services but has Rs 10,000 in cash and could give it to him in person. But the caller refused, insisting to seek a shopkeeper's help to transfer the money. Mr.X was afraid that the caller may be a kidnapper and asked his driver to pose as a shopkeeper and handed over the phone to him to send Rs 10,000. The transaction failed the first time but was successful on the second attempt. Then the man kept demanding more. By that time, Mr.X reached the test centre, but the security personnel didn't allow him to check on his son. Later, he sought help from local police, who took a picture of his son sitting inside, assuring he was safe. After that, Mr. X approached the cyber cell in Noida and filed a written complaint.

Case 2: Mr.Y, an MCD engineer who lives in Delhi's Pitampura had received a call from a number with a '+92' country code from a person threatening to implicate his son, who is pursuing his MBA in Hyderabad, in a rape case. The caller told him that his son was caught with a gang involved in heinous crimes and as he seemed to be from a good family, they intended to release him, provided Mr.Y pay them. Mr.Y heard his son crying over the phone, which sounded exactly like his voice. First, they demanded Rs 50,000. When Mr.Y said he didn't have that much of money, they asked Mr.Y to pay Rs 30,000 and Mr.Y paid.

Mr.Y's friend suggested him to call his son to check on him. Mr.Y could come to know after payment of Rs.30,000 to fraudsters that son was in college and was fine.

These scams can be particularly hard to detect, as the voice sounds genuine. However, we need to exercise the following precautions:

- ✤ Be wary of unexpected calls or messages, especially from unknown numbers or claiming urgency.
- Don't share personal information or authorise transactions over the phone without verifying the caller's identity through other means.
- Pay attention to any inconsistency in the voice, like robotic-sounding delivery or unnatural pauses.
- Be cautious about sharing your voice online.
- Limit the amount of personal information you share publicly including audio recordings.
- Enable two-factor authentication (2FA) This adds an extra layer of security when accessing your accounts.
- Verify caller Identity Do not trust caller ID alone. Always try to verify the caller's identity through other channels before sharing any personal information.
- If you receive a suspicious call or message, report it to the authorities and the relevant organisation the scammer was impersonating.

The fraudsters target and play with the emotional bondage old-age people have with their close relatives. The aged people are easy targets for the fraudsters in this area. Please exercise caution. If you receive a call from yourson or daughter or any relative from an unknown number, even under emotional stress, please try to take time to talk to your son or daughter or the relative from whom you supposedly received the call, to confirm that the call what you received is genuine and not fake.

It is your hard-earned money – Keep it safe – Do not fall prey to the tricks of fraudsters, who will always try to loot your money in many innovative ways. Never open any link in Whatsapp for transfer of money. Keep your personal details safe and do not disclose to anyone.

PAYMENT OF EX-GRATIA

We understand there is a growing agony in the minds of our members for the delay in payment or ex-gratia payable as per 12th Bipartite / 8th Joint Note. We have already advised that a sizeable number of pensioners eligible for enhanced amount of pension could not be included in last month's exercise and some more number of pensioners, the 7th bipartite retirees, have been found eligible for enhancement after adding PQP and FPA as per our long-lasting demand. The bank is trying hard to accommodate all the beneficiaries of the abolition of the 40:50 imbalance during this month's pension disbursement. This is a priority for the Bank as the Bank has to report back to the Court about compliance of Govt. order on the next date of hearing scheduled on 2nd May 2024.

The above is one reason for the delay in payment of ex-gratia. Secondly, as already shared with our affiliates/members, vide our letter No. 79/73-24 dated 15.03.2024, we urged upon the Bank to calculate the ex-gratia on notional calculation of pension at the rate of 50% as on 31.10.2022 for those who were being paid less than the amount, else those pensioners will get an inferior amount to their peers in other Banks who were getting 50% of last pay as pension on the effective date of ex-gratia, i.e. 01.11.2022. As the Bank has found reason in our submission, the same has been forwarded to the IBA for their clearance, which is yet to be responded to. We are waiting with our fingers crossed but with a hope in our minds for a positive response.

We hope that rank and file will appreciate the reason for delay in payment of ex-gratia and maintain restraint for some time further to ensure similarity in benefit for all.

KEEP AWAY FROM PROPAGANDISTS

We are watching with utter dismay that some of our members have been sharing texts released from time to time the one Shri Umesh Sharma on behalf of so-called GOP (group of pensioners) in different WhatsApp groups formed by our units without knowing that the so-called GOP is not of a representative character and that they have gone to the Delhi High Court in 2016, much later to our Federation, as we submitted our petition at the Supreme Court of India for adjudication in the year 2011, which was subsequently transferred to the High Court in 2013. she will find that the advocate engaged by the GOP seldom spoke, mostly he remained silent spectator of the proceedings. The presence is so negligible that the Court did not ask them to submit any representation to the DFS. The order dated 13th April 2023 to submit a representation to DFS for consideration by a Committee was aimed at to our Federation only providing us an opportunity to speak before the Committee, first ever opportunity offered to any organization of Pensioners in the banking industry, and through our deliberation before the Committee we could establish that 40:50 imbalance is an 'anomaly'. Resultantly, new era of 50% for all' has ushered in for the pensioners/employees of State Bank of India.

Now as the credit of this achievement glorifies solely the Federation of SBI Pensioners' Associations, Shri Sharma is circulating texts showing his keenness to achieve retrospective effect of the gain to constantly remain in the focus of attention.

As in our previous communications, once again we iterate that our prayer before the court is for 50 per cent of last pay as pension for all, cutting across cadre and pay divide, from the date of one's retirement, and we have no reason to accept anything less than that. When on 22.01.2024 Addl. Solicitor General apprised the court about the decision of government to abolish the 40 : 50 divide in payment of pension in State Bank of India and prayed for closure of the case as the same has virtually become in fructuous, our advocate strongly objected to that saying we will prefer adjudication on our prayer as we could gather that the payment will be made prospectively, while our prayer is for retrospective payment, i.e. from the date of one's retirement. Resultantly, a new date has been fixed on the 2nd May 2024, so that we and the court as well can take a clear view after actual compliance of the order of the Government.

Friends! We are waiting for a judicial disposal on our prayer and our Governing Body has already taken a decision in its meeting held on 19.01.2024 at Thiruvananthapuram, that in the event the court upholds the decision of the Government for payment of the enhanced pension from a prospective date, the Federation will again appear before the Apex court for justice.

It will not be out of point to mention that only through court case our Federation could raise maximum pension from Rs. 1,000/- to Rs. 2,400/- and could bring in Family Pension in State Bank of India in the year 1979. Again through the present case we could bring justice for 5th to 7th bipartite retirees and now the abolition of 40 : 50 divide among retirees of State Bank of India.

Incidentally, this achievement will not only bring substantive financial benefit to the existing pensioners but all the serving employees who joined the Bank prior to emergence of the New Pension Scheme as well.

Now onwards, our fight will be to ensure enhanced pension from date of retirement and inclusion of FPP and PQA in the pension for all the 7th bipartite retirees.

Friends! I have faith in your organization, take pride of its achievements and don't get confused on the false propaganda being spearheaded by persons like Shri Umesh Sharma (GOP) himself as the sole saviour of the pensioners in SBI.
