SBI PENSIONERS' MEET, ADMINISTRATIVE OFFICE, WARANGAL AND 38TH ANNUAL GENERAL MEETING OF OUR ASSOCIATION HELD AT WARANGAL ON THE 23RD JUNE 2025

The SBI Pensioners' Meet was conducted by SBI, Warangal A.O., at the request of the Association, on the 23rd June 2025 at Dr. B.R. Ambedkar Bhavan, Hanamkonda Warangal District. On the same day, the 38th Annual General Meeting of our Association was also held as per the Notice issued by the General Secretary.

- For the first time, the SBI Pensioners' Meet was held at A.O. level after formation of Warangal A.O. by the Bank subsequent to bifurcation of Hyderabad and Amaravati Administrative Circles.
- The combined meeting of SBI Pensioners' Meet and Annual General Meeting of the Association was held for the first time.
- After the entire world was affected by the epidemic Covid-19, this meeting was the first Pensioners' Meet conducted by the Circle, after a long gap.
- This was the first general meeting in which respected Shri S. Radhakrishnan participated after taking over charge as Chief General Manager of SBI, Hyderabad Circle.

The activities started with Registration of Members and SBI Pensioners at 8.00 a.m. and breakfast was provided to all the participants. Colourful banners welcoming the dignitaries, members of the Association and SBI Pensioners attracted the participants.



The combined inaugural session started with invitation of all the dignitaries to the dais by Shri P. Bhaskara Rao, Deputy General Secretary (HQs) of the Association and felicitation by Shri Ghanshyam Solanki, DGM (B&O), SBI, Warangal A.O., Shri A. Ramesh Babu, General Secretary and Shri N. Radhakrishnan, President of the Association.

The Dais looked more colourful with the presence of Chief Guest respected Shri S. Radhakrishnan, CGM, SBI, Hyderabad Circle, Distinguished Guest Shri Ravi Kumar Verma, GM (NW-I), SBI, Hyderabad Circle, Special Guest Shri L. Chandrasekhar, General Secretary, National Confederation of Bank Employees, All India State Bank of India Staff Federation & SBI Staff Union Amaravati Circle, Guests of Honour and Special Invitees Shri Jitendra Kumar Sharma, DGM (B&O), SBI, Cyberabad A.O., Shri K.S. Ramachandra Rao, President, SBI Pensioners' Association Amaravati Circle, SBI Staff Union representatives Shri K. Sreenivasa Sandilya, General Secretary & Shri Ch. Sridhar, President, Shri H. Shankar, President, SBIOA (HC), Shri Samir Kumar Sinha, AGM (PPF&G), SBI, Hyderabad LHO, Shri D. Suryam, President, SBI SC/ST Employees Welfare Association along with Shri Ghanshyam Solanki, DGM (B&O), A.O. Warangal, Shri N. Radhakrishnan, President and Shri A. Ramesh Babu, General Secretary of SBI Pensioners' Association Hyderabad Circle.

The combined inaugural session commenced with Prayer song by Shri Ch. Trinadha Rao, our member and Lighting of Lamp by all the Dignitaries.





Shri Ghanshyam Solanki, DGM (B&O), SBI, Warangal, welcomed all and said that he is very happy for the opportunity to hold the first-ever SBI Pensioners' Meet at Administrative Office level along with the Annual General Meeting of the Association. He further said that he also feels proud on the presence of our respected Chief General Manager Shri S. Radhakrishnan as Chief Guest in the meeting as this being the very first meeting and visit to A.O. Warangal he is attending after taking over Chief General Manager of the Circle. DGM further sought the blessings of all Seniors and Super Seniors present in the meeting.

Shri N. Radhakrishnan, in his opening remarks said that the SBI Pensioners' Meet was initially started as "Get-together" at Circle level, which was later extended to be conducted at all A.O. Centres. He also informed that Bank Management later agreed for conduct of SBI Pensioners' Meet even in big centres, where the pensioners are present in large numbers. President thanked Circle Management Committee and Shri Ghanshyam Solanki, DGM (B&O), A.O., Warangal for their decision to conduct SBI Pensioners' Meet along with the 38th AGM of the Association acceding to the request of the Association. He also thanked all the employees of A.O., Warangal for their total support to the excellent conduct of the meeting. Shri Radhakrishnan further said that Bank has done everything for us whether it is our lifestyle, comforts, children education, status, etc. and since the Bank has now started mobilisation for deposits, it is our turn to exhibit our gratitude to the Bank. President suggested that every pensioner may open an R.D. Account of Rs.500/- p.m. (Minimum per family) to enable the Bank to get around Rs.15 Crore p.m. if all the 3 lacs SBI Pensioners open such Recurring Deposit Accounts.



President further said that the day needs to be remembered by all members for the instant acceptance of participation in the meeting by our respected Chief General Manager, Shri S. Radhakrishnan even before taking charge as CGM of the Circle and all the other dignitaries representing Circle Management and the serving employees' organisations. President conveyed that conduct of this meeting will be etched in golden letters in the history of the Association. He also said that every member should feel proud for the wholehearted support that is being extended by the Circle Management and the serving employees organisations and wished that the Association would scale to further greater heights in the days to come with the total support of Circle Management and serving employees' organisations.



Shri S. Radhakrishnan, respected Chief General Manager and Chief Guest attracted the attention of audience with his scintillating speech. Chief Guest said that he feels privileged to be present in the meeting which is held at a place where he can seek the blessings of Almighty as well as the Seniors and Super Seniors, who have laid the foundation for the premier position of the Bank in the entire banking industry. CGM further informed that the reality is every employee shall finally enter into the category of Pensioners. Chief Guest further assured that the Circle Management would ensure comfort to all the pensioners by providing resolution to the genuine grievances of the pensioners and said that he would be available 24/7 to everyone. The assurance of our respected Chief General Manager, Shri S. Radhakrishnan that he is available to everyone with just a message in WhatsApp attracted the pensioners and the thunderous sound of their applause reflected their true happiness.

Shri Ravi Kumar Verma, General Manager (Network-I) and Distinguished Guest said that he could come to know the origin of SBI Pensioner's Meet through this meeting. General Manager further said that he attended two Samadhan Pakwada Meetings and dealt with the grievances of individual pensioners, which were represented by the Pensioners themselves in those meetings. He also felt proud that as far as Hyderabad Circle is concerned, no single grievance is pending and all grievances represented in the Samadhan Pakwada were resolved. Shri Ravi Kumar Verma also informed that despite forums like Samadhan Pakwada, Structured Meeting, Pensioners' Meet, etc., any pensioner can approach him and submit his/her grievances at any point of time and every effort would be made to resolve the same at the earliest.



Our Special Guest, Shri L. Chandrasekhar, General Secretary, National Confederation of Bank Employees (NCBE), All India State Bank of India Staff Federation (AISBISF) and State Bank of India Staff Union Amaravati Circle (SBISUAC), while expressing his happiness for participation and seeking blessings of the elders, informed that NCBE has taken up three urgent issues of pensioners such as Change of Base Year for Dearness Relief from CPI (1960=100) Series to CPI (2016=100) Series, Improvements in Ex-gratia and Notional eligibility of Stagnation Increment to those concerned employees retired between May 2015 and March 2016. Shri Chandrasekhar further said that every effort would be made to resolve these issues at the earliest and unity amongst NCBE & AIBOC would certainly result in achievement of resolution to these issues. Shri Chandrasekhar also said that achieving the issues of pensioners would not only benefit the existing pensioners but also the employees who will be pensioners after their retirement.

Our Guest of Honour, Shri K.S. Ramachandra Rao, President, SBI Pensioners' Association, Amaravati Circle said that he always feels proud to participate in the meeting of Hyderabad Circle, which is the parent association of all pensioners in Amaravati Circle. He congratulated the efforts of Hyderabad Circle in making available the gracious presence of entire CMC, other management functionaries along with representatives of all serving employees' organisations in the combined meeting. He further said that the decision of Hyderabad Circle Association to conduct AGMs in all A.O. centres is commendable. Shri Ramachandra Rao appreciated the efforts of Shri L. Chandrasekhar, General Secretary, NCBE towards resolution of pensioners' issues and hoped that the united movement of NCBE and AIBOC would definitely yield good results. He suggested all pensioners to disclose the details of deposits, medical cards to their family members for use in case of emergency and also for registering nominations in respect of all accounts maintained by them.



Our Guest of Honour, Shri K. Sreenivasa Sandilya, General Secretary, State Bank of India Staff Union Hyderabad Circle greeted the dignitaries on the dais and all members present in the meeting. Shri Sandilya referred to the pensioners as the stalwarts of yesteryears and emphasized that their hard work and sacrifices have laid the foundation for the recognition of the Bank as the Best Bank, Best Employer and marked an indelible benchmark in HR practices. Shri Sandilya conveyed his gratitude for the opportunity to be present in the meeting of elders and expressed his gratitude to all the former union office-bearers under whose mentorship and guidance he was nurtured. He also appreciated the great role played by

the Pensioners' Association in the smooth enrolment/renewal of health insurance policies for pensioners. Shri Sandilya while conveying his best wishes for the grand success of the meeting assured the continued support from Union to the Pensioners' Association in all respects.

Shri Jitendra Kumar Sharma, Deputy General Manager (B&O), SBI, Administrative Office, Cyberabad, Special Invitee, said that Bank will always take care of Pensioners as the pensioners are the prime reason for the growth and prosperity of the Bank. He also appreciated the role of Pensioners' Association in the enrolment/renewal of Health Insurance Policies in achieving the No.1 position in PAN India for the last three consecutive years. 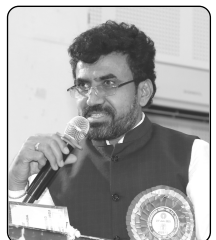

Shri D. Suryam, President SBI SC/ST Employees Welfare Association, Hyderabad Circle, Special Invitee said that the meeting has become grand success due to the presence of galaxy of dignitaries including the respected Chief General Manager, General Manager, Deputy General Managers, Assistant General Managers, representatives of serving



employees organisations and the strong leader of banking industry, Com. L Chandrasekhar. He further said that as CGM Sir conveyed all the employees are going to land in the pensioners' category only and expressed that the serving employees' organisations should play a pivotal role in achieving the benefits/facilities for pensioners as it would be benefitting even the future pensioners. Radhakrishnan, respected Chief General Manager, representatives of management and all the serving employees' organisations for their co-ordination and also for their gracious presence in the Annual General Meeting of the Association.

Shri Ramesh Babu exclusively thanked Shri Ghanshyam Solanki, DGM (B&O), SBI, Warangal A.O. for acceding to our request to conduct the SBI Pensioners' Meet on the day coinciding with the Annual General Meeting of the Association, which has made the combined meeting a Mega Event in the history of the organisation. He also expressed his heartiest thanks to all other employees of SBI, Warangal A.O. for their co-ordination in the conduct of this combined meeting.

Shri Ramesh Babu specifically thanked Com. Santhosh, Dy. General Secretary, SBISUHC for being with the Association from the beginning that resulted in the excellent conduct of this meeting. He also expressed his thanks to Shri Praveen, Dy. General Secretary, SBIOA (HC), the Government Department concerned for allotment of the spacious and comfortable Hall, Police Authorities and all others behind the successful conduct of this meeting.

After the speeches of all dignitaries, the stage was open for Interactive Session, wherein only one Pensioner, Shri Ramana expressed his grievances on the non-availability of some tablets in the Dispensary, Conditions on Empanelment of Hospital and the indifferent approach towards e-AB Pensioners. Warangal Dispensary Doctor, Dr. T. Kiroj responded to the queries on medicines and empanelment of Hospital and on the query of indifferent approach towards e-AB Pensioners, Shri N. Radhakrishnan, President replied that the Association treats equally every pensioner as SBI Pensioner citing examples where the Association has taken up the issues of e-AB Pensioners such as inclusion of disabled children as beneficiaries for Life-time Family Pension, Revision of Pension where the lower Special Pay was taken into account for Armed Guards and where lower PQP was taken into account In case of clerical employees retired between April 2017 and October 2018, even though they were not members of the Association.

The Inaugural Session, thus ended and after Lunch recess, the Annual General Meeting of the Association commenced.

After the opening remarks by President Shri N. Radhakrishnan, General Secretary Shri A. Ramesh Babu took-up items of Agenda, as per Notice dated 19.05.2025.

Item No.1: Confirmation of Minutes of previous AGM held on 15.04.2024

The House unanimously confirmed the minutes of the previous Annual General Meeting held at Nalgonda on 15th April 2024, the proceedings of which were published in April 2024 Bulletin.

Item No.2 & 3: Report of the General Secretary and Discussion & adoption of the Report

General Secretary Shri A. Ramesh Babu presented the Report, which, after deliberations, was unanimously approved by the House with certain additions/alterations proposed by the General Secretary. The following are the highlight proposals approved unanimously by the House:

- Ratification of Admission of New Members (Item No.4)
- Audited Statements of Accounts for the year 2023-2024 (Item No.5)
- Appointment of Auditors for the financial year 2025-2026 (Item No.7)
- Thanking our beloved Chairman, Shri Sreenivasulu Setty for bringing improvements in SBI Health Assist, despite restrictions under the contract period.
- Thanking AGM and other employees of PPF&G for the excellent coordination in general and for obtaining approvals from Corporate Centre for inclusion of eligible disabled children as Life-time Family Pensioners.
- All co-options of Office-bearers made by the Managing Committee during the interregnum between the last AGM on 15.04.2024 till the Current AGM.
- Proposal to send Monthly Bulletins through Mail for Pensioners aged upto 70 years excluding Sub-staff Pensioners and Family Pensioners.
- Proposal to collect outstanding dues of AGM contributions, from the members, for the last 10 years.
- Conduct of AGM once in three years at Hyderabad and other AGMs at any one of the A.O. Centres on rotation basis.
- Proposal that the practice of printing of Bye-Laws and distributing the same to all the members can be dispensed with, which would also be cost-effective.
- Amendments to Bye-laws as proposed by the Managing Committee, which are published in the following pages. (Item No.6)

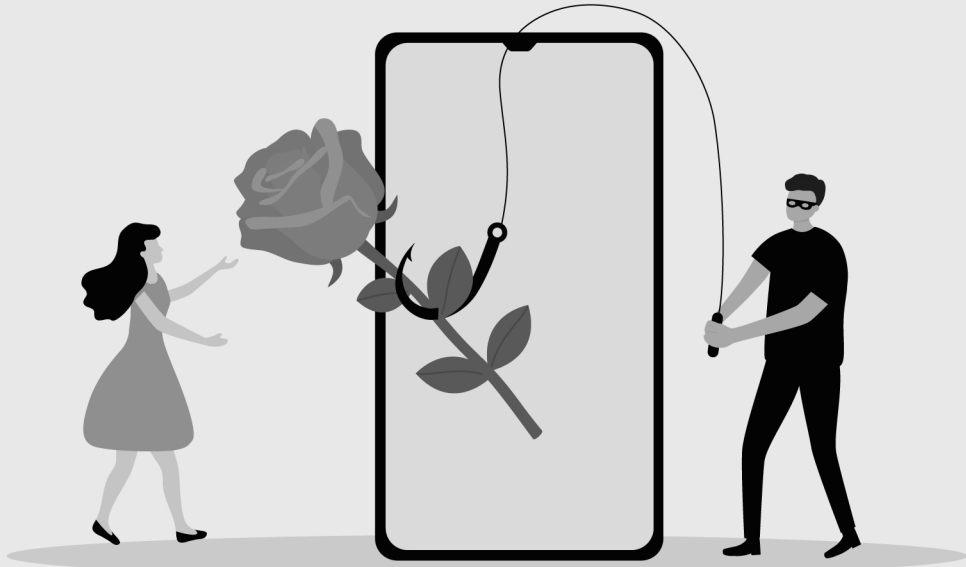

CYBERCRIME AWARENESS



Social Media Impersonation

Social Media Impersonation happens when someone sets up a fake account mimicking a real person or organisation. These fraudulent accounts are used to deceive others, often leading to identity theft, financial scams, reputational damage, and the spread of false information.

✓ Dos:

- **Verify Accounts:** Look for blue checkmarks, consistent usernames, and familiar profile pictures to confirm authenticity.
- **Be Cautious:** Avoid unsolicited messages and never share personal details or click suspicious links.
- **Report Impersonation:** Inform the platform and the real person or organisation being impersonated.

✗ Don'ts:

- **Confirm Fund Requests:** Verify requests for money from friends or relatives through a phone call or in-person meeting.
- **Don't Make Payments:** Avoid paying unknown individuals online and Untrusted / unverified charities.
- **Keep Info Private:** Never share personal or confidential details on social media.

CYBERCRIME AWARENESS



SMS, Email & Call Scams



SMS, Email, and Call Scams are used by fraudsters to deceive victims with fake offers. They impersonate trusted NBFCs by using their logos and fake IDs, gaining credibility. Scammers may send counterfeit sanction letters or cheques, asking for upfront payments. Once the payment is made, the fraudsters disappear with the money.

✓ Dos:

- **Verify Authenticity:** Always cross-check sender details and contact official sources directly.
- **Report Suspicious Messages:** Forward any fake messages to official reporting channels and warn others.

✗ Don'ts:

- **Don't Trust Unsolicited Offers:** Never trust loan offers via phone, email, or text without verification.
- **Don't Share Sensitive Info:** Avoid giving personal or financial details without confirming the legitimacy of the offer.
- **Don't Click Links or Open Suspicious Emails:** Don't click on links or open emails from unknown sources with attachments or links.
- **Don't Pay Upfront Fees:** Genuine lenders don't require upfront payments for loan processing.

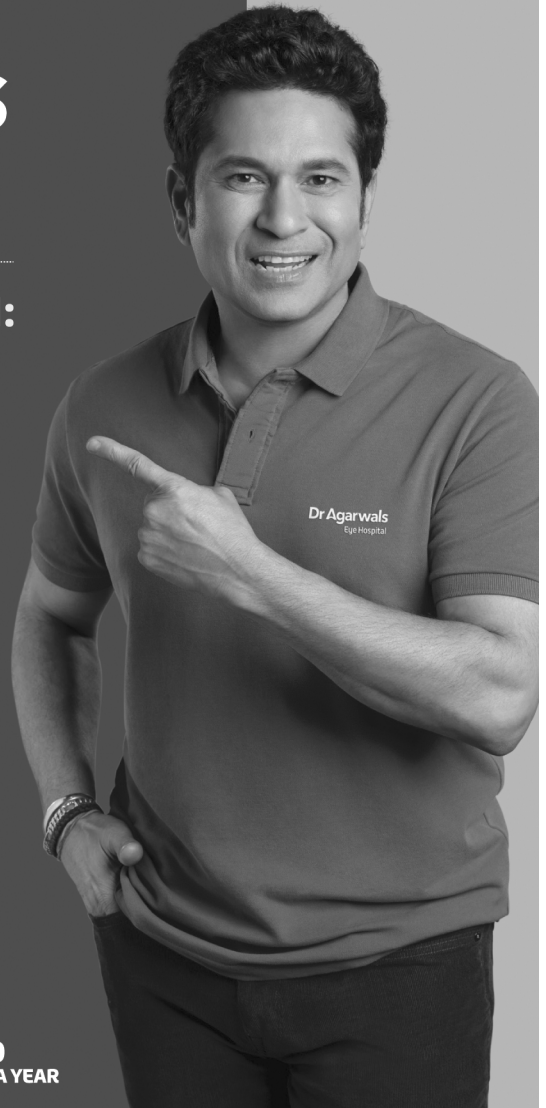
