### HOLIDAY HOME - ROLL OUT OF ONLINE BOOKING FACILITY

The online booking facility of holiday home has been rolled out, through HRMS Portal, for both serving and retired employees. The date of effective occupancy for online booking would be on or after 29.07.2023

**Eligibility:** The Serving or Retired employee & their Dependants as per HRMS will be eligible for the Bank's Holiday Home facility i.e., Father, Mother, Son(s) & Daughter(s)

#### Duration of Stay:

- The booking will be automatically confirmed (if available) for a maximum period of 4 days in one instance.
- In case of a longer period of stay (beyond 4 days in an instance), the approval will be accorded by CWC. (The status can be viewed in HRMS itself). In such cases, double rent will be charged for the period beyond 4 days.
- A total of 20 room days will be allowed to any serving or retired employee in a Financial Year.

- The booking of Holiday Homes can be done 120 days in advance.

#### Cancellation Charges:

- The booking charges debited to the account will be refunded if the booking is cancelled before 15 days of the proposed date of occupancy.
- **Under any circumstances, the booking charges will not be refunded if the booking is cancelled with less than 15 days of the proposed date of occupancy.**
- The booking charges will not be refunded and a Penalty of Rs.200/- will be levied for cancellation 1 day before proposed date of occupancy.
- The booking charges will not be refunded and a Penalty of Rs.500/- will be levied for cancellation on the day or No show on proposed day of occupancy.

#### The procedure for online booking of Holiday Home:

- ✓ Login to your HRMS with your **User ID** and **Password**
- ✓ Click on '**Holiday Home Booking**'
- ✓ Click on '**New Booking**'
- ✓ Select the '**Circle**' and '**Holiday home**' from the list
- ✓ Select the '**dates of stay**' and hit '**submit**' button

(Now, room availability and room capacity will be displayed)

- ✓ Select the '**room(s)**' and click on '**save and proceed**' button on the bottom right

- ✓ On the next screen, enter '**details of person(s)**' for stay in holiday home  
(Details of those in HRMS will be automatically displayed and you need to select the person - Add another person(s) by clicking on the '+' sign)
- ✓ Now, the system will display the '**total rent**' based on the days of booking, your '**mobile number**' as available in HRMS and your '**salary/pension account number**'.  
(An '**OTP**' will be delivered on the Mobile number mentioned in HRMS and e-Mail)
- ✓ Enter the **OTP** in the Pop-up window and click on '**submit**' button.
- ✓ Your pension account will be debited for the required amount.
- ✓ After deduction of charges, an Auto generated mail on registered e-mail will be sent, confirming the booking.  
(Please note that the booking page of HRMS shall include undertaking/ authorisation to debit the Salary/ Pension account of the employee)

### **PROVISION OF FAMILY PENSION TO THE ELIGIBLE DEPENDENT FAMILY MEMBERS OF A MISSING PENSIONER / FAMILY PENSIONER**

With reference to the above, we bring it to your kind information that provisions as under are stipulated in Family Pension Scheme in respect of employees whose whereabouts are not known:

- (i) The family pension shall become payable to the eligible family members from one year after the deemed date of death of the missing employee i.e., the date of police report or 01.05.1988, whichever is later;
- (ii) However, in respect of missing employees in whose case 7 years have elapsed since the date of missing prior to 01.05.1988, the entitlement of family pension begins from the date of completion of 7 years of missing as computed under section 108 of Indian Evidence Act or the date of introduction of Family Pension Scheme, whichever is later;
- (iii) The amendments are effective from 11.02.1993

2. We recall that provisions have been made in the case of a missing employee, as a measure of social security, to cut short the period of 7 years, as given in Section 108 of the Indian Evidence Act, 1872, after which the presumption of a missing person being no longer alive may be raised, and enable the family pensioner to receive family pension after a period of one year after the date of police report. However, there is no such provision in the case of a missing pensioner /family pensioner, the eligible family member of the pensioner or the next eligible family member of the employee may be granted family pension.

3. In the circumstances, we request that the provisions as above may be made applicable even in case of missing pensioners/ family pensioners. Further, considering the great deal of hardship to the families of such missing employees, pensioners and family pensioners, we request that the provisions can be made in tune with the following amendments effected in the CCS (Pension) Rules, 1972 by the Government:

- a) In the case of a missing employee/pensioner/family pensioner, the eligible family member can apply for the grant of family pension six months after lodging of Police Report, after observing the following formalities:
  - (i) The family must lodge a report with the concerned Police Station and obtain a report from the Police, that the employee/pensioner/family pensioner has not been traced despite all efforts made by them. The report may be a First Information Report or any other report such as a Daily Diary/ General Diary Entry;
  - (ii) An indemnity Bond should be taken from the nominee/dependents of the employee/pensioner/ family pensioner all payments will be adjusted against the payments due to the employee/ pensioner/family pensioner in case she/he appears on the scene and makes any claim.
- b) In all the cases, the eligible family pension shall become payable to the eligible family pensioner from six months after deemed death of the employee/ pensioner/ family pensioner i.e., the date of Police Report.

4. The Office Memorandum issued by Department of Pension & Pensioners' Welfare, Ministry of Personnel, P.G. & Pension, Government of India vide F.No.1/17/2011-P&PW (E) dated 25.06.2013, containing the consolidated instructions regarding grant of Family Pension to the eligible family member of the Government employee/ pensioner/ family pensioner is enclosed for your ready reference.

5. We request that our representation is taken up with the appropriate authority at Corporate Centre along with your recommendations towards resolution of the issue at the earliest. Please advise us the developments in this regard.

Respected Sir,

**GRANT OF FAMILY PENSION TO AN UNMARRIED OR WIDOWED OR DIVORCED  
DAUGHTER OF DECEASED EMPLOYEE/PENSIONER OF THE BANK.**

You are aware even after 75 years of our independence, most of our girls are still dependant on their parents before marriage and on her husband during a married life. In many cases where she remains unmarried or get widowed or get divorced she becomes dependent on her parents. And, after death of her parent(s), she becomes dependant on charity of others unless she can earn a livelihood by herself.

Our Bank's Pension Regulation provides for family pension for a daughter till she attains the age of 25 years or starts to earn, whichever is earlier. The Govt. of India Pension Rules (1972) had similar provision for girl children of a Govt. servant/pensioner. But after weighing the ground reality, the Rule has been amended and in accordance with Rule 50(a) of the Central Civil Services (Pension) Rules, 2021, "an unmarried or widowed or divorced daughter of a deceased Government Servant/pensioner, who is not earning her livelihood, is eligible for family pension beyond the age of twenty five years for life until she gets married or remarried or until she starts earning her livelihood, whichever is the earliest," subject to such conditions as is detailed in the related Circular dated 26.10.2022, a photocopy of which is enclosed herewith for ready reference.

In this connection, we shall be obliged if your good self initiate steps to amend our Pension Regulation in the line of the Govt. of India, the biggest employer of our welfare state, to ensure a lifetime financial support to the hapless girls of great State Bank family. The generous steps as proposed will surely be a life saving initiative to match one of our national slogans of Beti Bacho', particularly in the time when the entire country is observing Amrit Mahotsav' of our national Independence.

### SENIOR CITIZENS HELP LINE

Ministry of Social Justice & Empowerment (MOSJE) decided to establish state helplines at each state level and have a single call management platform and unique number **14567** that will enable services for the senior citizens through a National level structure. Thus Elder Line was conceptualised.

Elder Line will operate on all seven days of the week from 8 AM to 8 PM since it is categorised under non-emergency service and extension of working hours will be backed by findings and requirement.

National Implementing Agency (an empowered Committee) set up by MOSJE along with NISD (National Institute for Social Defence) is currently hosting the Elder Line along with the States. Operationally, the state agencies will be working closely with all state departments and district functionaries to deliver services. This is a collaborative approach between MOSJE, State departments, Identified state agency, NGOs, local senior citizens group, voluntary groups etc.

Elder line has two key components, a connect centre that has officers who empathise with the senior citizen and understand the problem faced by the elder supported by a strong field support that takes care of "on the field" interventions that are required out of the service requested by the senior citizen.

Services offered to senior citizens are broadly categorised into four services:

1. **Information** - Doctors, Hospitals, Old Age Homes, and Activity centres etc.
2. **Guidance** - Legal, Maintenance act related, Pension related queries
3. **Support** - Life, anxiety, relationship management and emotional support
4. **Intervention** - Direct (addressing abuse of elders and conducting rescue of homeless and abandoned elders) and Indirect (building ecosystem)

### RBI LAUNCHES UDAM - CENTRALISED WEB PORTAL FOR SEARCHING UNCLAIMED DEPOSITS

The Governor, Reserve Bank of India today launched a Centralised Web Portal UDAM (Unclaimed Deposits - Gateway to Access information), This portal has been developed by RBI for use by members of public to facilitate and make it easier for them to search their unclaimed deposits across multiple banks at one place.

The Reserve Bank of India had announced the development of a centralised web portal for searching unclaimed deposits as part of the Statement on Developmental and Regulatory Policies dated April 06, 2023. Given the increasing trend in the amount of unclaimed deposits. RBI has been undertaking public awareness campaigns from time to time to sensitise the public on this matter. Further, through these initiatives, the RBI has been encouraging members of public to identify and approach their respective banks for claiming unclaimed deposits.

The launch of the web portal will aid users to identify their unclaimed deposits / accounts and enable them to either claim the deposit amount or make their deposit accounts operative at their respective banks. Reserve Bank Information Technology Pvt. Ltd. (ReBIT), Indian Financial Technology & Allied Services (IFTAS) and participating banks have collaborated on developing the portal.

To begin with, users would be able to access the details of their unclaimed deposits in respect of seven banks presently available on the portal. The search facility for remaining banks on the portal would be made available in a phased manner by October 15, 2023.



## FREE HEALTH CAMP - CONTINENTAL HOSPITAL

Members are aware that our Association was in discussion with Circle Management and the Continental Hospitals, Financial District, Cyberabad for conduct of a FREE HEALTH CAMP for SBI Pensioners/Family Pensioners and their spouses. Accordingly, the free health camp was conducted exclusively for SBI employees, Pensioners & Family Pensioners on the 6th August 2023.

Group messages were sent by Shri A. Ramesh Babu, General Secretary requesting all the SBI Pensioners/Family Pensioners, those who wish to attend the said camp, to register their names through What's app to Shri N. Radhakrishnan, President and Shri P. Bhaskara Rao, DGS(HQ). There was an overwhelming response from our pensioners in the registration process and more than 220 Pensioners/Family Pensioners registered themselves. Hospital Authorities also provided the facility of e-Registration for registration of employees.

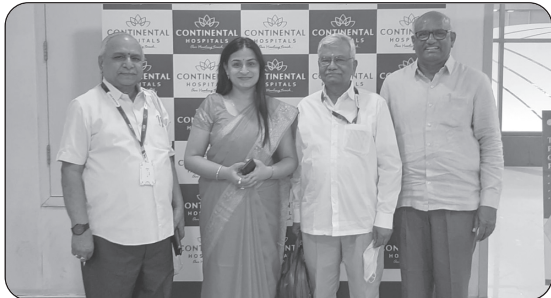

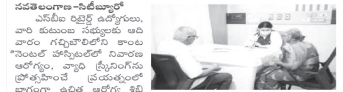

## AADHAAR LINKAGE TO PAN

We received complaints from some of the members that their accounts were credited with less Pension for July 2023 than their eligibility.

On enquiry, PPG Department informed that the deduction of Tax @ 20% has been effected to those pensioners who have not linked their PAN with AADHAR Card, which is mandatory. We are also informed that the amount of tax deducted can be claimed only while filing IT Return for the current financial year.

We advised all our Members, who have not linked their Aadhaar with Pan, to do so immediately to avoid further deduction of Tax from their pension.

**In this connection, SBIPA, Hyderabad Circle has also sent the following request to AGM, PPG, SBI, Hyderabad LHO, for further action at his end.**

The Pan Card was invalidated in the month of July 2023 in case of those who have not linked their Aadhaar with Pan. We had informed our members, who have not linked their Aadhaar with PAN, to do the same immediately.

We understand that Income Tax will not be deducted during the current month (Aug 2023) in respect of all those who have linked their Aadhaar with Pan, upto the date of processing of Pension.

But, in case of those who gets their Aadhaar linked with Pan between 20th & 30th Aug 2023, if IT is deducted even though they don't come under the purview of tax, they will suffer.

Hence, we request for reversal of such IT deductions before remitting the same to IT Department, during first week of next month.

Please do the needful.
