# **READ & LEARN**

## e-PHARMACY SCHEME FOR THE MEMBERS OF SBI HEALTH ASSIST (Policy-B) FOR POLICY YEAR 2024-25

The retirees will have an option to select their preferred e-Pharmacy vendor from the following list of four vendors under e-Pharmacy scheme for the Year 2024-25:

SI. No.	Name of e-Pharmacy Vendors	e-Pharmacy App

The members will place order for medicines required for them, spouse and disabled child (as per Bank's records) by uploading a valid prescription issued by a Registered Medical Practitioner, within the following limits:

<b>Total e-Pharmacy Limit</b> to the members of SBI Health Assist for the Policy Year (16th Jan of the current year to 15th Jan of subsequent year)	Rs. 18,000/-
Member's contribution (No reimbursement can be claimed from the Bank against such expenditure	
incurred by the members under any other scheme of the Bank)	Rs. 6,000/-
Bank's contribution	Rs. 12,000/-

The mobile applications will also have functionality of re-ordering the medicines, without the requirement of re- uploading the previous prescription.

Proportionate billing to members with "self-contribution" and "Bank's contribution" @1:2 ratio subject to maximum "Bank's contribution" during the policy year will be available.

Members joining SBI Health Assist (Policy 'B') midway during the policy year are eligible for pro-rata amount of "self-contribution" and "Bank's contribution" based on residual period (in completed months) of the policy year.

## Registration in the App of the Service Provider::

- > Log in into the App of the Service Provider with the Mobile Number registered under HRMS.
- > A One Time Password (OTP) will be generated and sent to the mobile number as registered under SBI Health Assist.

#### MARCH 2024

> There is no provision in the App to use one Mobile Number for more than one PF Index Number.

## Address for delivery:

- The address that has been provided to the Service Providers by the Bank will be displayed by default on the App of the Service Provider.
- A facility to deliver medicines at other addresses also, which can be recorded by the members in the App of the Service Provider.
- > The e-pharmacy applications have provision of delivery of medicine on a temporary address.

## Correction of Data:

- The error relating Registered Mobile Number, email ID and permanent address should be rectified in HRMS portal.
- > The issue needs to be taken up through Administrative Office concerned with Corporate Centre for rectification.

#### User Guide for the entire process flow:

#### **Prescription:**

- A valid prescription as per the Drugs & Cosmetics Act and Pharmacy Practice Regulation, 2015 which should be clear and legible and must contain name and age of the retiree and / or spouse/ eligible disabled children (if any).
- Validity of a Doctor's prescription will be 180 days for chronic cases and 60 days for acute cases. The Service Providers also have a facility for consulting doctors online at free of cost in case the prescription is not valid.

#### **Discount:**

- > On eligible prescribed allopathic medicines Discount @ 20%, on MRP printed on the cover of the eligible medicines, is provided to members.
- > The discount rate as above will not be applicable for OTC/Consumables/Surgicals and are not covered under e-Pharmacy scheme and will be provided upon payment by members.

#### Process flow for delivery of medicines:

- After receipt of requisition from the member, Service Provider will arrange for a confirmation call to confirm the order and quantity of the medicines. Confirmation call may not be necessary under certain modes of order as per the policy of the Service Provider.
- > Only after confirmation by the member, order shall be considered for further processing.
- > Only allopathic medicines will be supplied to the members.
- Orders can be placed 24x7 i.e. any time during the day and on all 7 days of the week. A member will receive Prescription Validation Call to confirm the order within 4 hours of uploading the prescription on the App. If an order has been uploaded after the operating hours (i.e. after 6 PM), member will receive prescription validation call the next day.
- Members will be allowed to purchase medicines even beyond the limit of Rs.18,000/- by making full payment from their own sources and the Service Provider will allow applicable discounts on such purchases also.

> Payment options available are detailed in the user guide provided by Service Providers.

## Turn around Time (TAT):

- Standard TAT is 1- 3 days for certain PIN codes in Metro/Urban areas and 3 5 days for selected PIN Codes in Semi Urban/ Rural areas and in some areas, the TAT may be upto 10 days also.
- The list of PIN Codes with TAT and locations covered for delivery of refrigerated medicines are available on Pension Seva Portal.
- > Members are requested to order medicines well in advance.

## **Delivery of Medicines:**

- > Members shall have to show original prescription and valid identification proof during delivery of medicines.
- No Service Charges, Fees or any additional expenses should be paid by the members in addition to the amount of the bill raised by the Service Provider.
- Upon delivery of medicines, members should check if correct medicines have been delivered and in case of wrong product delivered, damaged packaging, damaged medicines, medicines expired/near expiry date etc. a complaint must be lodged immediately by email/phone or through the complaint management system in the app. Detailed conditions and process for such returns shall be applicable as mentioned by the Service Providers in their App.

## Cancellation of Order:

- > Return of medicines will not be accepted after delivery.
- There shall be a provision of cancellation of order by the members. A member can cancel the order till the time status of the item purchased is not showing "Order dispatched" in the App. Cancellation after "Order dispatched" status will attract a penalty of Rs. 100/- (Rupees One Hundred only) which will be recovered from the member by the Service Provider.

# **ANNUAL GENERAL MEETING ON 15TH APRIL 2024 AT NALGONDA**

It has been decided by the Managing Committee to conduct the next Annual General Meeting (AGM) at Nalgonda on the 15th April 2024.

In the erstwhile Hyderabad Circle of the Bank, there were A.O. Centres in places like Hyderabad, Secunderabad, Tirupati, Vijayawada, Visakhapatnam and Guntur and the mandatory AGMs of the Association were held at different venues. After bifurcation of the erstwhile Hyderabad Circle into Hyderabad Circle and Amaravati Circle in the year 2017, new A.O. Centres have been created in Hyderabad Circle viz., Nalgonda, Nizamabad and Warangal.

Shri N. Radhakrishnan, President proposed that (i) the AGM, where the elections need to be conducted (once in 3 years), can be conducted in Hyderabad and (ii) the remaining AGMs need to be conducted in other A.O. Centres on rotation basis in order to strengthen the organisation at the whole circle level. President further conveyed that members residing at other A.O. Centres should also be given equal priority by the Association. President also conveyed that conduct of AGM at other A.O. Centres would be cost effective too.

The suggestion of President was unanimously accepted by the Managing Committee.

## Appeal to membership:

Conduct of Annual General Meeting is mandatory and as quoted above, conduct of AGM at other A.O. Centre in one way would be cost effective and very much essential for the Association to be financially stronger. In the circumstances, we once again submit that all those members, who have not remitted the mandatory contribution towards AGM are requested to remit the same immediately without any further delay.

After bifurcation, as far as the record goes, the proposed AGM at Nalgonda is the first AGM that is being conducted outside Hyderabad Centre. Hence, all members are requested to attend the Annual General Meeting scheduled to be held on the 15th April 2024 at Nalgonda and make it a grand success.

# STRUCTURED MEETING HELD BY CIRCLE MANAGEMENT ON THE 27<sup>TH</sup> FEBRUARY 2024

The Structured Meeting for the half-year ended March 2024, was held by the Circle Management on the 27th February 2024. The meeting was attended by the stipulated number of office-bearers from the Association and management representatives on the other side.



We have taken up the issues faced by the Pensioners in obtaining sanction of stagnation increment as per notional/actual eligibility, release of salary arrears by the last worked branch and requested for issuance of categorial instructions to branches. It was reported by the AGM, PPG that only few cases are pending and however assured to do the needful.

On updated Pension Payment Advice to Pensioners and Family Pensioners and Revision of Family Pension in respect of cases relating simultaneous sanction of Family Pension, the Management responded that the issue has already been escalated to Corporate Centre and assured that the issues would be resolved soon.



We have once again represented that applicability of minimum pension/family pension to pre-1986 SBI Pensioners and Family Pensioners, as per Government directives and as agreed under the Minutes between UFBU and IBA, should be effected at the earliest. The management assured to follow-up the same with Corporate Centre.



We have also raised issues faced by the members in the arena of Health Insurance such as Sanction of Medical Bills based on final diagnosis, early approval of payments in respect of cases recommended by the Rejection Review Committee, e-Pharmacy related issues and nonreceipt of hard copies of Insurance Cards. The TPA present in the meeting was advised by the management to follow-up with the Insurance company for resolution at the earliest.



We have further taken up issues relating Issuance of ID Card of Pensioner on the date of retirement, conduct of Pensioners' Meet at all A.O. Centres and also additional office space for the Association to which the management responded positively.

# **EX-GRATIA FOR PENSIONERS**

Members are aware that the wage negotiations between the UFBU and IBA were concluded and the 9th Joint Note in respect of Supervising Staff and 12th Bipartite Settlement in respect of Award Staff were signed on the 8th March 2024.

The Unions/Associations have been demanding for periodical updation of pension along with every wage revision settlement. However, the issue regarding updation of pension is already sub-judice before various courts including the Hon'ble Supreme Court. In the circumstances, the Unions/Associations have requested that without prejudice to the court cases, some ex-gratia may be extended to the pensioners/family pensioners.

The above demand of Unions/Associations was accepted by IBA and for the first time in the history of bipartite settlements, a clause has been included in the 12thBipartite Agreement dated 08.03.2024, for provision of payment of Ex-gratia relief for all pensioners/family pensioners, including SBI pensioners/ family pensioners as under.

# **RETIRED DURING THE PERIOD**

The brief details of e-gratia relief are as under:

- The monthly ex-gratia amount shall be paid, as a one time measure, in addition to the pension/ family pension paid by the public sector banks including SBI, for the current bipartite settlement/joint note period from 01.11.2022 to 31.10.2027;
- The monthly ex-gratia will be paid to all pensioners and family pensioners, who became eligible to draw pension on or before 31st October 2022 including those who retired on 31.10.2022.
- The said ex-gratia amount will not attract any other allowance including dearness allowance/dearness relief.
- The ex-gratia amount will be renewed annually and the next review shall be undertaken in April 2024;
- The ex-gratia shall be paid on the specified matrix provided in the agreement for different settlement periods and shall be payable effective from 01.11.2022;

- Ex-gratia amount payable shall be the Basic Pension attracting DA/DR Plus DA/DR paid for October 2022 multiplied by the factor as provided in the Table hereunder after rounding up/down to the nearest 100;
- The Basic Pension mentioned above means the full basic pension as on 31.10.2022 and not the reduced basic pension after deduction of commutation;
- For Part-time employees, the ex-gratia shall be based on the Basic Pension drawn by them and DA/ DR as applicable on the Basic Pension.

### FURTHER DEVELOPMENTS :

Some of the issues and demands raised by the Unions could not be taken up for discussions and resolved and Minutes of Discussions held between Indian Banks' Association and AIBEA, NCBE, BEFI, NOBW AND INBEF on 08.03.2024 contain the following issues and demands relating Pensioners/ Family Pensioners, which shall be discussed further to reach a mutually acceptable and amicable resolution of the same within a maximum period of six months from the 8th March 2024:

- Updation of Pension of past retirees:
   Provision to be made in the Pension Regulations to provide for periodical updation of pension along with wage revision settlement/s;
- > Improvements in Pension Scheme;
- > DA Scheme for all pensioners to be at the uniform Index of 8088 points;
- > Inclusion of Special Allowance for superannuation benefits.

## PROPOSED WAGE REVISION UNDER 21<sup>th</sup> BIPARTITE AGREEMENT. UPDATION OF PENSION

We have come across a Memorandum of Understanding between your organisation and the United Forum of Bank Unions. In Para 5 of the said Memorandum, the issue of Updation of Pension has been mentioned, wherein it is proposed to provide Ex-Gratia Payment to the pensioners in the name of updation, without resolving the issue.

We are surprised that you have agreed to this arrangement, which is inconsistent with the present Pension Regulation. The Pensioners of the Banks were looking to you that you will initiate the process of updation of pension system of Banks. The entire Bank Retirees Community is deeply disappointed that instead of providing proper structure for pension updation in Bipartite Agreements, you have resorted to avoid your responsibility and have provided Ex-gratia as a method of providing relief to pensioners which is patently unjust and unfair.

We believe that IBA should have understood that the pensioners were not looking for a quantum of relief but were expecting structure changes in the Bipartite Settlements providing for automatic relief to commensurate with increase in 'pay' with every wage revision. Your action, therefore, was not upto the aspiration of Bank Pensioners.

It would have been appropriate to provide a platform to the pensioners community to place before you their expectation and aspiration.

You are aware that the Every Pay Commission, appointed by the Government of India, always provides relief to government pensioners along with change in pay scale for serving employees. RBI & NABARD has already updated the pension of their retirees, we cannot appreciate why the similar arrangement was not considered by IBA for Bank pensioners. We feel IBA has failed in its duty as a benevolent organisation and have ignored the community of the pensioners.

We understand that detailed discussions about the disbursement of the wage package is being conducted. We urge upon you to provide a platform to the organisations of the pensioners and reconsider your decision on the Pension Relief Issue.

We await your response and are looking forward to an invitation to place our point of view on the subject before you.

2. The Govt. of India, DFS, vide their letter eF.No. 4/2/1/2022-IR dated 13th March, 2024 (copy enclosed), has conveyed No Objection to Public Sector Banks to pay adhoc amount/ on ad-hoc basis, as per agreed provisions of 12th Bi-partite Settlement/9th Joint Note, pending amendments to the relevant regulations, of —

- (i) Arrears, revised salary and allowances to serving officers with effect from 1.11.2022;
- (ii) Revised pension and arrears to existing pension optees, retired with effect from 01.11.2022; and
- (iii) Monthly ex-gratia [not attracting any other allowance] w.e.f. 1.11.2022, to pensioners and family pensioners [who became eligible to draw pension on or before 31.10.2022], as a one-time measure, for the current bipartite period.

3. Banks may accordingly take appropriate steps to implement the Joint Note/Bi-partite in their respective banks as mentioned in Para 2.

# REVISED SCHEME FOR COMPASSIONATE APPOINTMENT / REVISED SCHEME FOR PAYMENT OF EX-GRATIA AMOUNT IN LIEU OF COMPASSIONATE APPOINTMENT

# MODIFICATION – REMOVAL OF EXCLUSION CLAUSE FOR EMPLOYEES WHO HAVE DIED AFTER COMPLETION OF 60 YEARS OF AGE BUT BEFORE RETIREMENT ON SUPERANNUATION

Circular No. CDO/P&HRD-PM/54/2023 - 24 dated : 22-02-2024

We refer to our e-Circular No. CDO/P&HRD-PM/33/2020-21 dated 04.09.2020 & e- Circular No. CDO/ P&HRD-PM/92/2020-21 dated 17.03.2021 on the captioned matter.

2. The Bank implemented the Revised Scheme for Payment of Ex-gratia amount in lieu of Compassionate Appointment & Revised Scheme for Compassionate Appointment to provide financial assistance to the bereaved family of deceased employee who have died in service. However, it was observed that the families of a segment of employees were not able to receive the benefits of the above Schemes due to the exclusion clause for employees who died after completion of 60 years of age but before retirement on superannuation.

3. The competent authority has now approved modifications to the "Revised Scheme for Compassionate Appointment" & "Revised Scheme for Payment of Ex-gratia amount in lieu of Compassionate Appointment" as detailed hereunder: -

- (i) Removal of the exclusion clause for the dependents of deceased employees, who had completed the age of 60 years in the month of retirement on superannuation in the Bank. Such families may be included in the coverage of the Revised Scheme for Payment of Ex-gratia amount in lieu of Compassionate Appointment & Revised Scheme for Compassionate Appointment.
- (ii) The above modifications will be applicable for the "Revised Scheme for Payment of Ex-gratia amount in lieu of Compassionate Appointment" w.e.f. 01.04.2020 in line with original scheme.
- (iii) The above modifications will be applicable for the "Revised Scheme for Compassionate Appointment" w.e.f. 24.03.2020 only for COVID-19 deaths, and w.e.f. 24.02.2021 for all other cases in line with original scheme.
- (iv) In all above cases, where the families were excluded due to the aforementioned provision, the dependents may apply / reapply under the Revised Scheme for Payment of Ex-gratia amount in lieu of Compassionate Appointment or Revised Scheme for Compassionate Appointment within 03 months from the date of the circular.
- 4. All other terms and conditions of the schemes shall remain unchanged.
- 5. DMD (HR) & CDO has been authorized to issue any clarifications on this matter.

Vijaya Madhavi recollected their experiences with the pensioners they had worked with earlier and assured assistance if any issues arise during transactions at bank branches.

Shri PSVS Sarma, General Secretary, expressed gratitude to Shri Manish Kumar Singh for his prompt attention to the meeting. Later, he summarized developments regarding various issues of pensioners, such as increasing the Family pension to 30% from the existing 15%; providing 100% neutralization of Dearness Relief for pensioners who retired between 01.01.1987 to 31.10.2002; and fixing the pension at a uniform rate of 50% of the last 12 months' average basic pay. He also

revealed the matters regarding the DFS order in light of the Delhi High Court instructions. Furthermore, he thanked the constituents of UFBU and the efforts of our top Federation leaders before DFS, expressing hope that the Ex-gratia amount would be paid to all retirees simultaneously with the 12th Bipartite Settlement.

He brought to the notice of the members the misinterpretation of the latest circular instructions issued by the Bank, which caused the stoppage of monetary benefits to Scale-IV retirees. The Association has represented for payment of monetary benefits to Scale IV retirees as per the revised circular instructions. He explained the steps being taken at all levels by the Bank to solve the problems faced by our members under the E-pharmacy scheme. #### GAZETTE NOTIFICATION ISSUED FOR 50% OF LAST DRAWN PAY AS PENSIONABLE PAY TO ALL SBI PENSIONERS

Gazette Notification No. HR/P&PMD/SPL/SP/2023-24 dated the 18th March, 2024 -Clause-2(A) reproduced for information of members :

Provided also that with effect from the 10th November, 2023, notwithstanding the date of retirement or the Pay Scales in which the monthly substantive salary during the last twelve months' pensionable service is drawn, the maximum amount of pension for the members who retired or retire shall be computed at the rate of fifty per cent of the average of monthly substantive salary drawn during the last twelve months' pensionable service plus half of Professional Qualification Pay plus half of increment component of Fixed Personal Pay, wherever applicable (pro-rata in the case of parttime employees).

**Explanation** — The above proviso shall apply prospectively, and the pension shall be computed and payable under this proviso with effect from the 10th November, 2023."


