## **STAFF : MISCELLANEOUS - HOUSING LOAN SCHEMES FOR STAFF-CASES WHERE EMPLOYEES ARE DECEASED**

### **1) WRITE-OFF OF IHL WHERE ACCOUNT IS NPA**

### **2) WAIVER OF OUTSTANDING IN IHL WHERE ACCOUNT IS STANDARD**

### **ONE TIME GOODWILL PACKAGE FOR BEREAVED FAMILY**

**Circular No.: CDO/P&HRD-IR/62/2022 - 23 dated : 10-01-2023**

Home Loans are granted to employees of the Bank for acquiring suitable housing accommodation for them and their families, under Individual Housing Loan Scheme (IHLS). The employees can also avail Housing Loan on Commercial terms (like Public) to meet the shortfall in project cost.

2. In this connection, the Bank has obtained a Group Term Insurance Policy covering outstanding in home loan accounts of employees opened under Individual Housing Loan Scheme (IHLS). The annual premium on the policy is being paid by the Bank. Initially, the Group Term Insurance Policy was applicable to the outstanding in Staff Home Loan accounts which were sanctioned on or after 01.10.2014. Subsequently, from 01/07/2019 onwards, all Staff Housing Loan accounts under IHLS, irrespective of the date of sanction, have been covered under Group Term Insurance Policy and in case of death of an employee, outstanding in his/her IHL account is settled by raising claim with the Insurance Company (at present SBI Life).

3. However, there are cases where Staff Housing Loan accounts are NPA due to death of employees where repayment is stopped and also cases of Staff Housing accounts where employees are deceased, but accounts are standard as their dependents are repaying the dues from their own sources (like family pension etc.), due to non- coverage of insurance and/or claim from Insurance company is not received.

4. With a view to providing one time relief to the bereaved family, post death of their earning member and to secure house of their own without loan repayment burden, **the Executive Committee of the Central Board (ECCB) in its meeting dated 06/12/2022 has approved a Goodwill Package from the Bank, as under:**

- i. In case of deceased employee where Staff Housing Loan account has turned NPA, the outstanding in Staff Housing Loan accounts (including unrealized interest) will be written-off/adjusted.
- ii. In case of deceased employee where Staff Housing Loan account is STANDARD, the outstanding in Staff Housing Loan accounts will be waived/adjusted.

5. This goodwill package will, however, be subject to the terms and conditions mentioned in the ANNEXURE-A.

6. SOP for undertaking the exercise for write-off/waiver of the accounts involved is placed as ANNEXURE-B

7. DMD (HR) & CDO has been authorised to issue operational guidelines/clarifications in the matter, as necessary.

## TERMS AND CONDITIONS

- **This goodwill package is a one-time measure without forming any precedent whatsoever.**
- This goodwill package will be applicable to the loan accounts (NPA and Standard) with the **outstanding as on 30.09.2022 plus accrued interest** if any.
- This goodwill package **will not be applicable** to the loan accounts (NPA and Standard) which are already closed/settled.
- **This goodwill package is meant to have a roof over the head of bereaved family of the deceased employee, as such it will be applicable to Housing Loan availed by the deceased employee for the first house only.** However, If the employee has availed subsequent IHL after disposing of his existing house to have a bigger house/house in better location and at present that is only accommodation for the bereaved family, the said housing loan is also eligible for write-off/waiver.
- This goodwill package will cover Staff Housing Loan accounts under both IHL and Staff Housing Loan on commercial terms where employee is deceased (IHL includes IHL for ST/SC/OBC under separate schemes for purchase of property in notified / CNT areas).
- **The Circle must ensure the genuineness of eligible cases and the insurance claim to be thoroughly verified before write-off/waiver of the eligible staff housing loans.**
- If the Staff Housing Loan is eligible to be covered under Group Term Insurance as per sanctioned date and the date of death of the employee, the Circle must enforce the Insurance claim and settle it with Insurance company without delay. **Such loans are not eligible for write-off/waiver.**
- **Staff Housing Loan cases if any, where fraud is detected/suspected are not eligible.**

## STANDARD OPERATING PROCEDURE (SOP)

- Granular data on eligible cases as on 30.09.2022 will be shared by REHBU with the Circles.
- Processing of eligible IHL cases and accounting process for write-off/waiver will be as per the extant guidelines of the Bank on write-off of loan accounts.
- As such, wherever provision is held, the same will be utilized for the write-off and where adequate provision is not available, the same will be created for effecting the write-off.
- The delegation of powers for write-off/waiver as the case may be, will be as under without reference to the amount involved.
  - Sanctioning Authority for Waiver/Write-off as the case may be, of eligible cases will be the **General Manager** of respective Network in which branch falls.
  - All such sanctioned cases will be controlled by **Chief General Manager** of respective Circle.

Respected Sir,

We are forwarding you the following note regarding the problems of retirees of 7th & 8th Bipartite retirees, prepared by us, may help you to have an in-depth study of the problems.

"You are aware at the time of conclusion of 7th Bipartite Agreement (01.11.1997 to 31.10.2002 for Award Staff and from 01.04.1998 to 31.10.2002 for Sup-Staff), the Pay for the purpose Pension was defined as pre-revised salary plus merger of DA up to 1616 points. The settlement was arrived at a merger of 1684 points"

The SBI did not implement this arrangement and instead recommended to the Govt. to permit it to pay pension on merger of 1684 points. This proposal did not find favour with Govt. Without going in details of the struggle the Govt. finally appointed Murmu Committee to look into this issue.

Till such time all retirees of the SBI continued to draw pension on 6th Bipartite Salary Scale with 50% Pension up to 8500/- and 40% of Salary over 8500/- subject minimum of Rs.4250/- Murmu Committee approved amendments to this arrangement with 50% pay up to Rs.14240/- and 40% over Rs.14240/-. Subject to minimum of Rs.7120/-. The Bank implemented this recommendation and pension was revised and arrears were paid to affected staff. While calculating the arrears the PQA and FPA drawn by the staff was ignored without assigning any reason.

Pay for pension in SBI is calculated as under :

1. Sup-Staff – Basic Pay + PQA + FPA
2. Award Staff – Basic Pay + All other allowances on which the PF is recovered.

Accordingly, they should have been paid pension on according to this provision. We request you to have this issue examined and issue instructions for revising pension of such members of the staff on PQA and FPA.

Further, the 8th Bipartite Settlement (November 2002 to October 2007) provided that pension on the revised scale under that agreement will be paid from 01.05.2005, although salary scale were revised from November-20002 the pension was paid as per old provision of 50% up to 8500/- and 40% over that salary from 01.11.2002 to 30.04.2005. This provision was revised to 50% up to Rs.14240/- and 40% above that subject to minimum of Rs.7120/-. This part of changes were not affected for retirees from 01.11.2002 to 30.04.2005. These retirees have suffered injustice."

There issues requires review at Corporate Centre to avoid anguish and heart burning of old retirees.

Accordingly, we have requested the pensioners of all circles to submit the details of the said leftover cases. So that we can take up the matter with the Bank for initiating necessary steps to extend financial support to the left over such unfortunate wards of our pensioner's fraternity.

We are sharing a link to the spreadsheet document with some relevant information about said leftover cases. We would request to advise all circles managements suitably so that they advise the respective pensioners, family pensioners and also the surviving invalid children, after death of pensioners and their spouse, how to proceed further in this regard. The attached spreadsheet may not be an exhaustive list of left over such unfortunate hapless wards of pensioners of SBI FAMILY.

Incidentally, we like to submit that the Circle Management of our Chandigarh Circle have kindly constituted a Special Medical Board for examination of such unfortunate hapless children for extension of Family Pension.

We are confident that said problem will receive your kind and sympathetic and humane consideration and will surely extend all reasonable opportunities for having their livelihood for survival after the death of respective pensioners and their spouses.

## RATE OF INTEREST ON FIXED DEPOSITS

Bank is increasing Rate of Interest on Fixed Deposits. If any one wishes to avail the same in their existing FD without getting Pre-matured Payment, following is the procedure at the Branch end.

How many of us are aware of the fact that We can increase the rate of Interest of TDR/STDR without prematurely closing it?

Yes, we can do that. The facility is active now. \*Kindly sensitise the ground staff about it.

We don't need to close that TDR/STDR. And there is No Prematurely closure penalty here.

Plz follow Circular No. NBG/PBU/LIMA-TD/46/2010-11 dt. 29-03-2011

(The functionality was not active. But it is working now)

Branches should follow these steps :

1. Open Screen No 7047 in CBS
2. Enter the Account No. of the TDR/STDR that is to be prematurely closed (in order to increase its Rate)
3. Select appropriate product codes in "New Account Type" and "New Sub Category" fields.
4. Select appropriate options in "Interest Frequency" and "Interest Payment Method".
5. Enter the Tenure values in the fields Term Days, Term Months and Term Years.
6. The field "Waive Penalty" is kept "Y:Yes" by default. (Here is a catch. The penalty shall be waived of only if the deposit is renewed for a longer period than the balance period of the original deposit. In case, the new tenure is shorter than the balance period of original deposit, the field value should be changed to "N:No".
7. The field "New Term Value" is to be kept blank if the new Term Value is the same as closing balance of Old TDR/STDR. Otherwise the New Term Value is entered in the given field and the Account Number of the account from which the difference is funded is to be entered in the field "Transfer Account Number"
8. The beneficiary Account Number is to be entered in the field "Interest Trf Acct No." incase 'Transfer' is chosen as the Interest Payment Method.
9. Click on the Transmit Button to create the new TDR/STDR.

**Pensioners may approach the Branches to get above benefits.**

the members. He requested the members to feel free to contact him in case of any difficulty they experience at branches.

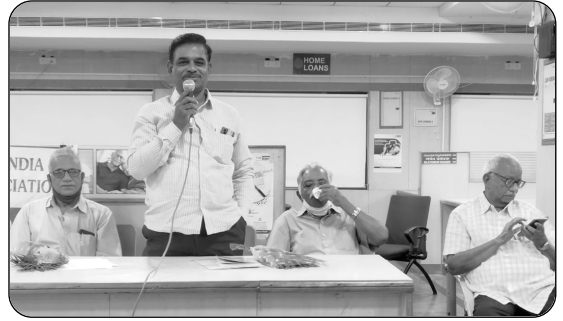
