SBI HEALTH CARE :: POLICY -A :: ONE TIME PAYMENT PLAN (OTPP)

Eligibility: Effective from 16.01.2023, the policy will continue to be available to new as well as existing members of SBI Health Care (OTPP), their spouses and disabled child/ children (if any) as declared to the Bank.

- Insurance will be obtained only for the members whose residual balance is Rs.3.00 lacs and above.
- If the claim exceeds the total sum insured allocated under the Policy, the balance amount of claim up to the residual limit will be processed by REMB Trust.
- Medical claims of members having balance below Rs.3.00 lacs will be paid by the Trust and they will be out of the insurance scheme.
- SBI REMBS/SBI Health Care Policy Members cannot join SBI Health Assist Policy mid-term during the currency of the Policy. They can join only at the commencement of cover.

New Members: The employees who retired/retires and received pension and applied within three (3) months from the date of receipt of his/her first pension may apply to become beneficiary of the SBI Employees Medical Benefit Scheme. New members joining the SBI Health Care will be migrated to Insurance policy on monthly basis and pro-rata premium will be paid by REMBS Trust on their behalf.

- Premium on both the Base plan and Super Top-up cover will be paid by the Trust. The liability of the Insurance Co. would be restricted to Base Plan plus Super Top-up or Residual Limit under SBI REMBS, whichever is less.
- Members, whose residual limit is above Rs.11.00 lacs, would be covered for the amount beyond Rs.11.00 lacs and up to their residual limit under SBI REMBS by the REMB Trust. For e.g., if a member is having residual balance of Rs.15.00 lacs in SBI REMBS, submits a claim for Rs.14.00 lacs to Insurance Company under SBI Health Care, Insurance Company will pay the claim for Rs.11.00 lacs (as per terms and

conditions of the Policy), which is up to maximum coverage limit under the Insurance Policy. Members can submit the claim for remaining amount of Rs.3.00 lacs under SBI REMBS for reimbursement. It will be paid by REMB Trust with deductions of non-payable / medical expenses as per rules and regulations of SBI REMBS.

Annual Domiciliary Limit under OTTP

- There will be a provision of domiciliary cover of 1 % of the lifetime limit (in SBI-REMBS) under SBI Health Care (subject to a cap of total 10% for the life time)

- The cost of Medicines, Investigations, and consultations, etc. in respect of domiciliary treatment shall be reimbursed for the period stated by the Registered Medical Practitioner in Prescription or 90 days whichever is earlier. If the treatment continues beyond 90 days, a fresh prescription must be submitted. In case the doctor advises lifelong medicine or follow up after one year or six months, the validity of the prescription would be maximum of 180 days.
- Domiciliary claim under SBI Health Care Policy can be settled from Super Top-up, if the Base Sum Insured is already exhausted and domiciliary limit for the year is available.

Delivery of Welcome Kit of SBI Health Care:

- a) Welcome Kit containing physical copy of Insurance Cards, Brochure of Policy features, List of Network hospitals and claim form will be delivered by Speed Post to the registered address of the members in the Policy.
- b) Once the Welcome Kit is despatched, TPA will share speed post tracking ID with member through SMS/ Whatsapp. In case of non-receipt of welcome kits, members may take up the matter with the TPA representative stationed at respective AO/ representative of the Broker (M/s. Anand Rathi Insurance Broker Ltd.) stationed at Selected AOs.
- c) Soft copy of the cards will be shared by concerned TPA on registered e-mail ID of the members.

Claim Procedure:

Cashless Treatment:

All policy holders should preferably opt for cashless treatment from the Network Hospitals of TPA (Third Party Administrator). In case of planned hospitalisation, the insured can obtain pre-authorisation from TPA, 4 days in advance. This shall enable him to just walk in with the authorisation to the hospital for a hassle-free treatment.

Hospitalisation:

- The communication regarding hospitalisation must be given within 7 days from the time of hospitalisation or before discharge, whichever is earlier.
- Claim documents must be submitted within 30 days of date of discharge or within 30 days of completion of treatment in case of Domiciliary treatment claim. Pre-hospitalisation claims to be submitted within 30 days of the completion of treatment or within 30 days after post-hospitalisation period of 90 days, whichever is earlier. In no case, the time period for submission of documents should exceed 3 months from the date of discharge or completion of 90 days of post-hospitalisation period, whichever is applicable.
- The insured should also furnish original of latest cancelled cheque of the Pension Paying Branch, attested photocopy of Aadhaar Card, Pan Card along with all the original documents.
- Members whose residual balance is rendered below Rs. 3 lacs should submit their claims to respective AOs.

DELINKING OF BANK ACCOUNTS FROM AADHAAR

Your good self is aware that fraudsters are looting the fortune of many a bank customers including Bank's pensioners and family pensioners since long. Their initial modus operandi had been using coded links and/or OTPs to syphon out money kept by their targets in bank accounts.

When people have been made aware about vulnerability of responding to the calls with requests of clicking a coded link or sharing an OTP, the fraudsters started using fingerprints as gateway to syphon out money from accounts of their targets, which are linked with Aadhaar Card. Invention of this easiest route of siphoning of money from bank accounts has sent a shockwave among the holders of bank accounts throughout the country as everybody is observing narrations of such incidents daily in hoards on TV Channels, Facebook and different WhatsApp groups.

In this connection, the Supreme Court of India on occasions, while disposing related suits, has clearly stated that sharing of Aadhaar Card is mandatory only for receiving Govt. subsidies. The Supreme Court of India has clearly stated in its judgements that sharing copy of Aadhaar Card cannot be insisted upon by any bank, telephone companies, schools etc. The judgements have been hailed by Shri N. Nilekani, the first Chairman of UIDAI, as the very purpose of floating the card has been correctly upheld by the court, the title of the Act being 'Targeted Delivery of Financial and other subsidies, Benefits and Services Act., 2016.'

In view of the foregoing and having regard to the fact that for many purposes including that of registration of a deed one has to share his fingerprints and as the registered deeds along with the biometric fingerprints are uploaded on related sites of the State Govt's., all the bank accounts linked with Aadhaar, which has a biometric gateway, have become highly vulnerable to frauds, we would request your good self to issue necessary direction to concerned authorities of the Bank to delink all the accounts from Aadhaar and to refrain from obtaining the same in future while opening a new account with the Bank.

Please treat this as extremely urgent.

Subject : 100% Dearness Relief (DR) Neutralization to pre-2002 bank retirees.

Sir,

Please refer to Indian Banks' Association's letter No. HR&IR / GOVT/BPS, dated 14.8.2023, on the above subject.

2. In this connection, the undersigned is directed to convey 'No Objection' of the Government to Indian Banks' Association, for advising Public Sector Banks, pending amendments to respective Bank Employees' Pension Regulations, to pay w.e.f. 1st October, 2023 :-

- (i) DR at uniform rate as applicable to the lowest slab of basic pension in the existing DR frameworks, to all pre-1/11/2002 retirees (100% neutralization of tapered DR);
- (ii) Rs. 800.00 and Rs. 450.00 per month as ex-gratia amount, as a standalone Benefit, which will not attract any DR, to pensioners/family pensioners falling under 1st slab of basic pension and drawing highest DR, and 2nd slab of basic pension attracting second highest DR in the present framework, respectively. The ex-gratia amount shall be absorbed in future changes in pension structure, if any; and
- (iii) No arrears shall be payable for the periods falling prior to the effective date.

SUBMISSION OF LIFE CERTIFICATE

It is known that it is mandatory for all SBI and e-ABs Pensioners/Family Pensioners to furnish the Life Certificate in the month of November each year on the prescribed format, failing which pension will be stopped two months thereafter i.e., from the month of January.

The following facilities are available for the Pensioners/Family Pensioners for submission of Life Certificate:

1. LIFE CERTIFICATE IN THE PHYSICAL FORM:

- Life Certificate in the physical form may be submitted in the prescribed format by the Pensioner/Family Pensioner in any Branch. The acknowledgement of having received the Life Certificate will be issued to the Pensioner/Family Pensioner by the Branch where the Life Certificate is submitted.
- After receiving the Life Certificate the Branch (Home / Non-Home) will verify the signature/ thumb impression from CBS and update the same in the related HRMS site. Life Certificate can be updated in the HRMS site by any officer of the Branch.
- When Life Certificate is submitted at a Non-Home Branch, **after updating the record in HRMS**, the branch shall forward the original Life Certificate to the Home Branch and retain a copy of the same for their record.

2. FACILITY TO SUBMIT DIGITAL LIFE CERTIFICATE:

Facility for submission of Life Certificate is also available to the pensioners through 'Jeevan Pramaan' – an Aadhaar based platform for biometric authentication of the pensioners.

3. STAFF PENSIONERS VIDEO LIFE CERTIFICATE SUBMISSION THROUGH myHRMS APP

The facility is available to all those staff pensioners who have not submitted the Life Certificate for the current year and those staff pensioners whose verified photograph is available in HRMS. (For photo uploading, staff pensioners can go to Upload Photo option in HRMS portal and then approach Branch for verification.)

Step 1. Login to myHRMS app

Step 2. Click on Life Certificate submission

Step 3. Click Record Video for the purpose of Life Certificate

Step 4. Click Record & Upload Video

- Answer questions asked during Video recording
- Select Close and submit Video recording
- Acknowledgement is generated and displayed on screen

Stage 2 – Approval by Bank Officials

The Video based Life Certificate is approved by the designated Bank Official at LHO level.

- In case any further clarification is required, the approving official calls the pensioner on the registered mobile number.
- On approval, email and SMS is sent to the pensioner.
- In case the uploaded "Video Based Life Certificate" cannot be approved for any reasons (viz., poor video quality, incorrect answers given by the pensioner etc.) the approving official rejects it with his remarks/comments. SMS and email is sent to pensioner with the remarks entered by the approving official.

STRUCTURED MEETING HELD ON 22.09.2023

The Structured Meeting for the Half-year ending September was held with our Association on the 22nd September 2023.

From the Management side, Shri Jitender Kumar Sharma, DGM & Circle Development Officer, Shri D. Harikrishna, AGM (HR), Shri Samir Kumar Sinha, AGM (PPG), Shri O.V. Ramanakumar, AGM (OAD), Shri M.V.R Lakshman Rao, Chief Manager (IR), Chief Managers (HR) of Hyderabad, Secunderabad and Cyberabad AOs along with employees from HR and PPG Departments attended. The representatives of AIRBL and Medi Assist were also present.

From our side, Shri N. Radhakrishnan, President, Shri A. Ramesh Babu, General Secretary, Shri M.S. Mohan Rao, Treasurer, Shri P. Bhaskara Rao, DGS (HQ), Shri K. Srinivasudu, DGS, S/Shri K. Jagannadha Rao, B. Purushotham, J. Satyanarayana, V.V. Rao and M. Ashok Kumar, Regional Secretaries attended. President, General Secretary and all office-bearers were welcomed with bouquets and from our side we have felicitated Shri Jitender Kumar Sharma, DGM & CDO and the new incumbents, Shri D. Harikrishna, AGM (HR) and Shri Laxman Rao, CM (IR).

The meeting started with a happy note of felicitation of three senior pensioners, Viz., Shri T. Chakrapani Rao, Retd. Dy. Manager, aged 90 years, Shri D. Kameswara Rao, Retd. Senior Assistant, 75 years and Shri Yellai, Retd. Havaladar, aged 75 years were felicitated by the Management and Association.

The issues raised in the last structured meeting held on 23.03.2023 were reviewed and we were informed that our letters seeking amendments to Family Pension Rules, as made applicable to Government pensioners, and stoppage of deduction of monthly commutation amount from the Family Pensioners were duly forwarded to Corporate Centre, for necessary action at their end. Regarding cleansing of data relating to Policy-B manual applications, it was assured that the task would be completed by 31st October 2023. On the issues relating to Medibuddy, we expressed our displeasure that proper cognizance is not given to the increasing issues of Pensioners to which, the Circle management advised us to submit detailed note along with screen-shots of messages received from Medibuddy by the Pensioners.

including subsequent clarifications issued by Indian Banks' Association)

ACTUAL ELIGIBILITY - DISPENSATION AS PER OLD NORMS

EMPLOYEES, WHO ARE ACTUALLY ELIGIBLE FOR ADDITIONAL STAGNATION INCREMENT EFFECTIVE FROM 01.11.2017

Clerical and Subordinate employees

Clerical and Subordinate employees, who are already in receipt of 8th Stagnation Increment are eligible for 9th Stagnation Increment of Rs.1990/- and Rs.1000/- respectively, effective from 01.11.2017 or two years after reaching 8th Stagnation Increment, whichever is later.

Clerical and Subordinate cadre employees who reached 8th Stagnation Increment (Basic Pay of Rs.42,020/- & Rs.23,785/- respectively) on or before 01.11.2015 are eligible for 9th Stagnation Increment with effect from 01.11.2017

Officers JMGS-I

Officers in JM Grade Scale I and who have moved to Scale-II and who have received 4 stagnation increments shall receive the 5th stagnation increment of Rs.2220/-, two years after receiving the 4th Stagnation increment or w.e.f.01.11.2017, whichever is later and will draw monetary benefits, which include arrears of salary.

Officers JMGS-I, who reached 4th Stagnation Increment (Basic Pay of Rs.51,490/-) on or before 01.11.2015 are eligible for 5th Stagnation Increment with effect from 01.11.2017

Officers MMGS-II

Officers in MMG Scale II and who have moved to Scale-III and who have received 4 stagnation increments shall receive the 5th stagnation increment of Rs.2220/-, two years after receiving the 4th Stagnation increment or w.e.f.01.11.2017, whichever is later and will draw monetary benefits, which include arrears of salary.

Officers MMGS-II, who reached 4th Stagnation Increment (Basic Pay of Rs.57,330/-) on or before 01.11.2015 are eligible for 5th Stagnation Increment with effect from 01.11.2017

Officers MMGS-III

Officers in MMG Scale III and who have received 5 stagnation increments shall receive the 6th stagnation increment of Rs.2500/-, two years after receiving the 5th Stagnation increment or w.e.f.01.11.2017, whichever is later and will draw monetary benefits, which include arrears of salary.

Officers MMGS-III, who reached 5th Stagnation Increment (Basic Pay of Rs.58,790/-) on or before 01.11.2015 are eligible for 6th Stagnation Increment with effect from 01.11.2017

Officers SMGS-IV

Officers in SMG Scale IV and who have received 1 stagnation increment shall receive the 2nd stagnation increment of Rs.2730/-, two years after receiving the 1st Stagnation increment or w.e.f.01.11.2017, whichever is later and will draw monetary benefits, which include arrears of salary.

Officers SMGS-IV, who reached 1st Stagnation Increment (Basic Pay of Rs.60,820/-) on or before 01.11.2015 are eligible for 2nd Stagnation Increment with effect from 01.11.2017

EMPLOYEES, WHO ARE ACTUALLY ELIGIBLE FOR ADDITIONAL STAGNATION INCREMENT EFFECTIVE DURING THE PERIOD BETWEEN DECEMBER 2017 AND OCTOBER 2020

All Clerical and Subordinate employees, who reached 8th Stagnation Increment and all Officer employees from JMGS-I to SMGS-IV, who reached the last Stagnation in their respective Scales between the period December 2015 and October 2018 shall be eligible for the additional Stagnation increment after 2 years of reaching the maximum stagnation.

ELIGIBILITY FOR NEW STAGNATION INCREMENT TO OFFICERS SMGS-V

Officers in SMG Scale V shall be eligible for one stagnation increment of Rs.2790/-, two years after reaching the maximum of scale or w.e.f.01.11.2020, whichever is later and will draw monetary benefits, which include arrears of salary.

Officers SMGS-V are eligible for one stagnation increment and consequential monetary benefits two years after reaching the maximum of scale or 01.11.2020, whichever is later

ELIGIBILITY FOR CONSEQUENTIAL MONETARY BENEFITS

In case of those who retired between 01.11.2017 and 31.10.2020, all superannuation benefits like Provident Fund, Difference in Gratuity (if applicable), Difference in Leave Encashment, Revision in Pension, Revised Commutation (if any), from the date of eligibility of their additional stagnation increment or 01.11.2017, whichever is later to be paid.

Role of Last served Branch of the employee**ACTUAL ELIGIBILITY**

- To arrange for Sanction of Additional Stagnation Increment as per actual eligibility under old dispensation.
- Disbursement of manual payment of arrears of Salary after sanction including payment of difference in leave encashment.
- Deduction of Member's and Bank's contributions of Provident Fund and TDS to be ensured simultaneously.
- PPG Department to be advised for further process of terminal benefits such as Provident Fund Refund, Difference in Gratuity (if applicable), Difference in Commutation (if applicable) and Revision of Pension from the eligible date of Additional Stagnation Increment.

NOTE: The eligible additional stagnation increment in respect of SBI Officers drawing Basic Pension of Rs.40,225/- and those with Average Substantive Salary between Rs.80451/- and Rs.1,00,562.50 will not have any impact on Pension as their Basic Pension is fixed at Rs.40,225/- i.e., Minimum payable pension who are covered by 40% clause. However, the Average Substantive Salary needs to be updated with the eligible additional stagnation increment for the purpose of effecting Revised Family Pension at the rate of 30% (without any ceiling)

NOTIONAL ELIGIBILITY – DISPENSATION AS PER NEW NORMS

- a) **After release of the additional stagnation increment and monetary benefits thereof**, in respect of employees who were in service on 01.11.2017, **the stagnation increments already drawn as per old norms shall be readjusted as per new norms** from three years periodicity to two years periodicity from the date of reaching their maximum of scale:

- d) For all employees, who were in service on 01.11.2017 but not on 01.11.2020 and otherwise eligible, the monetary benefits in pension are to be passed on from 01.11.2020. Such employees shall not be eligible for any benefit in gratuity, pension commutation and leave encashment or any other superannuation benefit on account of such readjustment of stagnation increment.

Role of Last served Branch of the employee**NOTIONAL ELIGIBILITY**

- a) To arrange for sanction of readjustment of Stagnation Increment with reduction of periodicity under new dispensation.

Many of them relate to errors in PPAs generated through HRMS and non payment of difference of personal allowance in few cases. He further informed, that the AO Rajahmundry have since relocated Bank Dispensary to a spacious accommodation for the comfort of pensioners and staff.

INTERACTION WITH MEDIBUDDY OFFICIAL

On Friday the 13th October 2023, Dr. Rajesh Shinde, Senior Manager, Medibuddy, Mumbai visited our Association Office at Koti to have discussions and obtain feedback on the issues faced by the Pensioners/ Family Pensioners of our Circle. The representatives of ARI BL and Medi Assist from the Circle also attended the meeting. Shri N. Radhakrishnan, President, Shri D. Krishna Kumar, Vice-President, Shri A. Ramesh Babu, General Secretary, Shri P. Bhaskara Rao, DGS (HQ) and Shri M.S. Mohan Rao, Treasurer from our side were present.

We presented the major issues faced by our members such as (i) Arbitrary cancellation of order, (ii) Inadequate stock of medicines, (iii) Supply of part medicines, (iv) Arbitrary change of dosage of medicines (For example, instead 40 mg supplying 20 mg medicines), (v) Arbitrary rejection of order quoting invalid prescription (vi) Undue delay in supply of medicines and (vii) Non-supply of refrigerated medicines including Insulin, Eye drops, etc. We also expressed the issues relating Wallet transactions such as wrong debits, undue delay in reversal of wrong entries, etc.

We categorically opined that Medibuddy Doctor services are not at all required inasmuch as the members upload prescription issued by their attending doctors. We suggested and also have insisted for provision of Medibuddy App exclusively for SBI Pensioners/Family Pensioners, which should be user-friendly and which can also ensure the agreed 20% discount on all bills. We also suggested for establishment of contact centres circle-wise with facility of interaction in local language.

Dr. Rajesh Shinde in his response said that the entire feedback/suggestions are taken in right perspective and assured for quicker remedial actions to provide a User-friendly App that can ensure comfort and convenience to the Users of e-Pharmacy.
