## NEW YEAR CELEBRATIONS 2026 – NEWLY ELECTED MANAGING COMMITTEE ASSUMES CHARGE

The New Year Celebrations welcoming 2026 of the SBI Pensioners' Association, Hyderabad Circle were held on 1st January 2026 at the Association's newly acquired and extended office premises, marking a significant milestone in its journey. The occasion also witnessed the formal assumption of charge by the newly elected Managing Committee for the term 2026–2028.

The New Year cake was ceremonially cut by the Association's veteran leader and outgoing General Secretary, Shri A. Ramesh Babu, amidst the enthusiastic participation of about 100 pensioner members, including the former and newly elected office-bearers and Managing Committee members and the editorial board.

Sri G. D. Nadaf, General Secretary, Federation of SBI Pensioners' Associations, greeted the new team through an audio message and spoke appreciatively of the active and vibrant role of Sri N. Radhakrishnan in effectively taking up pensioners' issues with the Corporate Centre. He also recalled the consistent and strong support extended by the Hyderabad Circle.


Shri N. Radhakrishnan, President, re-elected for a second term and also President of the Federation of SBI Pensioners' Associations, addressed the gathering and outlined the activities and achievements of the Association, while presenting the roadmap for the new term. He placed on record deep appreciation for the nearly two decades of selfless and seamless service rendered by Sri A. Ramesh Babu, who brought recognition and stature to the Association not only at the Circle level but also at the All-India level during his tenure as General Secretary of the Federation from 2015 to 2022 and said that the difficulties faced by Shri Ramesh Babu in the follow-up of Court Case cannot be forgotten in the achievement of uniform pension at 50% for all SBI Pensioners.

Shri D. Krishna Kumar, the newly elected General Secretary, appealed for the continued support and cooperation of the members for the smooth conduct of the Association's affairs. He paid rich compliments to Sri A. Ramesh Babu, who assumed the office of General Secretary in 2007 - within less than a year of his retirement in 2006 - and carried the responsibility for 19 long years, sacrificing his retired life for the welfare of pensioners. He recalled his invaluable contributions as General Secretary of Federation from 2015 - 2022 which included correction of pensions of past retirees, providing strength and relief to many aged pensioners, ensuring doorstep delivery of medicines through the Bank Dispensary during the COVID-19 pandemic, and establishing the practice of uninterrupted payment of pension to pensioners who had submitted life certificates but whose uploads were pending, thereby avoiding hardship to members.

Thereafter, Shri A. Ramesh Babu expressed his heartfelt gratitude to the pensioner members of the erstwhile combined Hyderabad Circle, the present Hyderabad Circle, and the Bank's Management for their unstinted support throughout his tenure. He formally handed over charge to the newly elected General Secretary, Shri D. Krishna Kumar, and the newly elected Managing Committee members, and wished them every success in carrying forward the responsibilities of the Association.

Sri I. Krishnam Raju, newly elected Deputy General Secretary, proposed vote of thanks and appealed to members to participate in large numbers in the Formation Day - 42nd Anniversary Celebrations scheduled for 2nd January 2026.

The inauguration commenced with unveiling of the plaque on inauguration by our respected Shri S. Radhakrishnan, Chief General Manager and cutting of ribbon by both the General Managers Shri Ravi Kumar Verma and Shri Satish Kumar.

The event became more colourful with the launching of Health Insurance of the Bank - SBI Health Assist (Policy-B) for the policy year 2026-27 through Cake Cutting by Shri Priyadarshi Pankaj, DGM & CDO, Shri Raj Kiran, AGM(HR), Shri Ajit Kumar, AGM(PPG) and Shri Sridhar Babuji, AGM (Premises) along with our General Secretary, Shri A. Ramesh Babu.

Shri Ajit Kumar, AGM (PPG) informed on the improvements brought by the Bank in SBI Health Assist (Policy-B) such as increase in subsidy to 90% for pensioners aged 80 and above, increase in wallet subsidy, reduction in member contribution under e-Pharmacy, Coverage of Angioplasty other than heart problems with a cap of Rs.5 lacs and said that every pensioner needs to avail this facility.

Shri N. Radhakrishnan, President conveyed his heartfelt thanks on behalf of the entire membership to the CMC for its total support to all initiatives of the Association. President expressed that the presence of entire CMC despite their very tight schedule shows the care and concern what the CMC has for the pensioners community. ## IMPORTANT NOTICE

### GROUP MEDICLAIM POLICY FOR SBI RETIREES "SBI HEALTH ASSIST " RENEWAL OF THE POLICY FOR POLICY YEAR 2026-27 EXTENSION OF LAST DATE FOR ENROLMENT

It has been decided to extend the last date of enrolment till **31st January 2026**.

It may be noted that no risk will be assumed during the break in period for the **existing members** who would renew their policy after 15 th January 2026 and the **cover would start only from the date of payment of Annual Premium by the member**. In these cases of renewals waiting period will not be applicable.

However, in case of **new enrolments**, there will be a waiting period of 30 days from date of payment of Annual Premium or from date of commencement of Policy whichever is later.

Further, in case of **new retirees**. (i.e. retired on or after 16 th January 2026) pro-rata premium will be applicable and waiting period will not be applicable for new retirees.

## FORMATION DAY - 42<sup>nd</sup> ANNIVERSARY CELEBRATIONS - A GRAND SUCCESS

The Formation Day – 42<sup>nd</sup> Anniversary Celebrations of the SBI Pensioners' Association, Hyderabad Circle were held on 2nd January 2026 at Sundarayya Vignana Kendram, Bagh Lingampally, Hyderabad, in a simple yet elegant manner.

The programme began with the invocation of Lord Ganapathy's blessings by Smt. Valli Krishna, a world record holder in mirror image writing, setting an auspicious tone for the meeting.



The prestigious venue was graced by the presence of the Chief Guests, Sri Ravi Kumar Verma, General Manager (Network-I) and Sri Satish Kumar, General Manager (Network-II), flanked by Sri Priyadarshi Pankaj, Deputy General Manager & Circle Development Officer, whom pensioners fondly regard as their Guardian.



The occasion was further enriched by the affectionate presence of leaders of sister organisations, namely Com. Hatkar Shankar and Com. K. Anjaneya Prasad, President and General Secretary of SBI Officers' Association, Hyderabad Circle; Com. Ch. Sridhar and Com. K. S. Sandilya, President and General Secretary of SBI Staff Union Hyderabad Circle; Com. D. Suryam and Com. V. Bhargava Kumar, President and General Secretary of SBI SC /ST Employees' Welfare Association Hyderabad Circle; and Com. K. Raju, General Secretary of SBI OBC Employees' Welfare Association, Hyderabad Circle, all of whom added strength and solidarity to the programme.



Shri Ajit Kumar, AGM (PPG), the custodian of pensioners' matters, and Sri Dayakar, AGM (OAD), overseeing operational and welfare-related services, also participated in the celebrations, obliging the invitation of the Association.

Shri I. Krishnam Raju, Deputy General Secretary (HQ), extended a warm welcome to the members and invited the guests on to the dais. Shri N. Radhakrishnan, President of the Federation of SBI Pensioners' Associations and President of the Hyderabad Circle and Shri D. Krishna Kumar, General Secretary, jointly honoured the dignitaries with a shawl, rose bud, and memento amidst warm and heartfelt applause from the members.



In his opening remarks, Shri N. Radhakrishnan thanked the entire membership for his re-election as President and for election of the New Committee and lauded the overwhelming participation of pensioners, the gracious presence of Senior Management functionaries despite their busy schedules and the affectionate support of sister organisations. He also acknowledged the presence of the Assistant General Managers of PPG and OAD, the Super Senior members, former President Shri A. Damodaram, the Election Committee Members headed by Shri L. S. N. Sarma, and the dedicated panel of the Bank's Doctors.

While expressing his gratitude to the Circle Management Committee for provision of additional office space to the Association, President recalled the speech of respected Chief General Manager, Shri S. Radhakrishnan and appealed to all Pensioners and Family Pensioners to mobilise deposits for the Bank so as to retain the Bank's premier position in the Country.

Calling for unity among all pensioners, President expressed gratitude to the Circle and Corporate Management for resolving several long-pending issues, including inclusion of 23 eligible cases of disabled children for lifetime family pension, release of notional benefit of stagnation increment to SMG-IV officers, as per provisions under 7th Joint Note, pending since 2015, and rectification of pension anomalies relating to 7th Bipartite retirees and rectification of family pension anomalies since the upward revision effective from April 2021. He also traced the history of the Association, highlighting its formation on 6th December 1983, following its separation from the then Pensioners' Association of Calcutta, and the celebration of Formation Day independently from 2023 onwards. President further appealed for involvement of all members in the membership mobilisation, which would further strengthen the Association.

Sri Ravi Kumar Verma and Sri Satish Kumar, in their addresses, shared valuable insights on organisational growth, employee welfare, and the continuing importance of cyber awareness and customer protection. Their speeches were received with keen interest and warm appreciation by the members.



Shri D. Krishna Kumar, General Secretary, in his maiden address, thanked the members for the confidence reposed on him by electing him with a thumping majority. He called for greater participation of members in the Association's activities and emphasised the need for a focused membership drive to bring into the fold those pensioners who have so far remained outside the Association, thereby making it stronger like a rope bound by many strands and more vibrant, enabling members to remain active, hale, and healthy. He appealed to the membership not to approach the Management individually on all and sundry matters, but to remember that unified representation would yield more effective engagement and meaningful results.

General Secretary profusely thanked Sri S. Radhakrishnan, Chief General Manager, for setting new benchmarks in recognising and addressing pensioners' concerns with sensitivity and promptness. He also referred to the empathy and generosity of the Chairman, Sri Sreenivasulu Setty, towards pensioners, highlighting initiatives such as improvements in the SBI Health Assist Policy, enhancement of premium subsidy to 90% for Super Senior Pensioners and the SBI Tribute initiative.

The Bank's Doctors- Dr G. Sudhir (associated with the Bank on a contractual basis for over four decades), Dr. Vijaya Kumar (Dental Surgeon for nearly three decades), Dr. K. ## **TIE-UP ARRANGEMENTS WITH DIAGNOSTIC CENTERS FOR LAB TESTS**

It is known that with a view to providing the facility of diagnostic tests to employees/retired employees and their dependents, the Bank entered into tie-up arrangements with diagnostic centres of repute for X-rays and routine pathological tests.

2. In the present-day polluted environment, even youngsters are affected by grave diseases such as cancer, heart, lung, kidney diseases, etc. The pattern of diagnosis has undergone a sea-change and some of the modern tests are very much essential for people of all age-groups. Further, we submit that retired employees, have to incur more expenses on tests advised by the treating doctor for proper diagnosis and are not reimbursed with the costs incurred on such precautionary tests, even under Insurance.

3. The Bank is pioneer in providing welfare measures to employees and retired employees. The Bank has already approved and included 33 pathological tests in the list of pathological tests recommended by the Bank's doctor to be done at empanelled lab, the facility of which can be availed by both employees and retired employees. Taking into consideration the age factor and the need for precautionary tests that are essential in the present polluted environment, we humbly submit that the following tests, which are considered a essential by the treating doctor, are included in the list of pathological tests recommended by the Bank's doctor to be done at empanelled lab:

1. Mammography test	2. Vitamin B-12 Test	3. VitaminD-3 Test
4. Laryngitis test	5. C.T. Scan	6. Echocardiogram test

4. In case of tests suggested by the attending doctors which are not in the Bank's approved list of tests, an arrangement should be made with the empanelled labs to charge discounted rate for our staff and pensioners as it is observed that such discounts are provided by the labs to selected patients referred by selected doctors. We should also ensure that rates of tests be same in all Labs in that centre. However, it is necessary to increase such Diagnostic Centres in metro and bigger cities.

5. Our just request, if acceded to, would benefit majority of the needy pensioners and family pensioners. Thanking you Sir in anticipation. Awaiting for your positive response.

## **NOMINATION BY PENSIONERS FOR LIFETIME ARREARS**

We are thankful to the Bank for provision of Nomination facility for Staff Pensioners for settlement of undisbursed pensionary dues, which was approved by the Central Board of the Bank and the same was published in the Gazette of India dated 20.03.2024.

2. Regarding the procedure for submission of nominations, it is stipulated as under:

- a) To register the nomination, an application on Form-A has to be submitted in Triplicate, one copy each to be retained at pension paying branch, Circle PPG and PPG, AMC, Kolkata.
- b) The nomination application on Form-A to be sent by personal service after taking receipt or by sending through registered post acknowledgement due to the respective branch of the Bank through whom pension is drawn.

3. In respect of nominations for deposit accounts, (i) the Bank record the status regarding registration of nomination on the face of the Passbook/Statement of Account and TDR, with the legend "Nomination Registered" and the bank also shall indicate the name of the Nominee(s) in the Passbook/Statement of Accounts and TDR in such cases. In respect of nominations for Provident Fund & Gratuity, the names of nominees are indicated in the Provident Fund Statements issued to the employees.

4. In this connection, we submit that even though, an acknowledgement is given by the Branch Manager of the Pension Paying Branch on Form - 'A', submitted by the Pensioner, there is no system in vogue to advise the Pensioner that the said nomination is registered / recorded in PPG, AMC, Kolkata.

5. Inasmuch as the nomination made by the pensioner is a conclusive proof with regard to the person nominated to receive the amounts specified, we suggest for exploring the possibility of

- (i) advising the pensioner that the nomination submitted by him/her has been registered/recorded at PPG, AMC, Kolkata and/or
- (ii) indicating the names of nominees registered by the Pensioners, in the Monthly Pension Slips of the Pensioners

6. We trust and hope that our just suggestion would be considered favourably.

7. Please acknowledge receipt of this communication and advise us the developments in this regard.
