## **READ & LEARN**



#### **FAMILY PENSION**

The Family Pension Scheme applies to every confirmed employee who is a member of the Pension Fund and who dies while in service after putting in a minimum pensionable service of one year or who dies after retirement from service and is on the date of death drawing pension.

#### FAMILY MEMBERS WHO ARE ELIGIBLE FOR FAMILY PENSION:

**SPOUSE:** The widow / widower up to her /his death or remarriage whichever is earlier.

- ✓ Family pension will be payable to the spouse even if he/she is in employment.
- ✓ If the pensioner leaves behind him more than one wife, if the personal law applicable to such employee permits such marriage, the family pension is payable to the widows in equal proportion.

**CHILDREN:** Failing above, the eldest of surviving children in order of their birth.

- ✓ In the case of Son, the Family Pension will be payable till he attains the age of 25 years or is gainfully employed, whichever is earlier.
- ✓ In the case of unmarried daughter, until she attains 25 years of age or until she gets married gainfully employed whichever is earlier.

**Note:** The words "gainfully employed" shall mean that he/ she is either self-employed or is otherwise employed and is earning from such employment an income more than the amount of family pension to which he/she is entitled. Where the earning is less than the entitled family pension, the amount of family pension will be payable but will be reduced by the amount of such income.

**TWIN CHILDREN:** In case of twin children, family pension will be payable to both in the proportion of 50:50. Provided further that when one such child ceases to be eligible his/her share will revert to the other child and when both of them cease to be eligible, the family pension shall be payable to the next eligible single child/ twin children.

**DISABLED CHILDREN:** The family pension shall be payable to such son or daughter for life if he/she is physically crippled or disabled so as to render him or her unable to earn a living even after attaining the age of 25 years. Provided that disability, which manifests itself in the child before retirement or death of the employee while in service, shall be taken into account.

**ADOPTED CHILD:** The adopted child despite adopted after the death of the employee would be entitled to family pension. However, before taking decision, the adoption deed should be thoroughly examined with a view to confirm that the adoption is a valid one and the deed is in order and does not contain anything which is contravention to the Adoption Act applicable to the pensioner.

**PARENTS:** The eligibility for family pension will be as per the sequence Spouse/ Children/ Parents. Failing normal sequence, to the parents who were wholly dependent upon the employee when he/she is alive provided the deceased employee has left behind neither a widow nor a child. Among the parents, mother will have precedence over father.

**FAMILY PENSION OF DECEASED EX-SERVICEMEN EMPLOYEE/PENSIONERS:** Family Pensioners of the deceased Ex-servicemen employees/pensioners of the Bank are allowed to draw family pension from Bank as well as Government/ Military w.e.f. 24.09.2012 or thereafter. These provisions were also allowed in past cases, however, the financial benefit was granted from 24.09.2012.

**SIMULTANEOUS SANCTION OF FAMILY PENSION:** To avoid difficulty in calculating Family pension due to non-availability of old records on the death of pensioner, and to facilitate the spouse to draw family pension without delay, sanction of family pension simultaneously with pension has been introduced.

On the death of pensioner, in cases where the simultaneous sanction of family pension has been made, the spouse eligible for family pension, shall approach the Pension paying branch and submit the following:

- ➤ ANNEXURE III Form for application for grant of family pension.
- > ANNEXURE III A Family pension declaration.
- Letter of Indemnity executed by family pensioner duly stamped with Rs. 200/-.
- Life certificate (Family pensioner).
- Death certificate in original.
- Xerox copy of Pass book of savings bank account to which pension is credited. (The account should be in the name of family pensioner in single CIF)
- ➤ K Y C documents of family pensioner (AADHAR Card, PAN Card etc. Xerox copy)
- > Any documents of Deceased pensioner (ID card, pension sanction advice etc.)

All the above documents to be attested by Branch Manager, wherever necessary, and to be forwarded to AGM, PPF&G Dept LHO under covering letter from Pension paying branch, for commencement of the payment of family pension to the spouse of the deceased pensioner.

In cases where simultaneous sanction of family pension has not been made and in cases where the claimant is a beneficiary, OTHER THAN THE SPOUSE, the papers mentioned hereunder are to be submitted in quadruplicate, prepared by the Branch from where the employee had retired or by the Branch from where last pension was drawn by him/her.

- Declaration of family members and their dates of birth duly signed by the applicant.
- > Form of application for grant of family pension. This form should also contain date of birth of all eligible dependents, their occupation with income and should be signed by all claimants.
- Non-remarriage / life certificate duly signed by claimant at the first instance and in November every year.
- ➤ All the annexures should be signed and recommendations to be made by the Branch Manager and should be forwarded to PPG Department through the Controlling Authority. This should contain old basic pay and allowances in case family pension at normal rate is not payable, two separate computation sheets be enclosed one with new basic pay and the other with old basic pay and allowances.
- 4 copies of death certificates duly attested by the Branch Manager.

**FAMILY PENSION AT NORMAL RATE FOR 5 YEARS:** In terms of existing instructions, the family pensioner is eligible, in case of death of the pensioner before expiry of five years of retirement, for family pension at full rate of normal pension, for the balance period of five years from the date of retirement.

#### **FAMILY PENSION ELIGIBILITY:**

- i. Presently, the eligible family pension is at a uniform rate of 30% of 12 months' average substantive salary of the deceased employee without any ceiling, effective from 01.04.2021.
- ii. In no case, the amount of family pension determined shall exceed the pension drawn by the pensioner.

#### PROVISION OF FAMILY PENSION TO DISABLED CHILDREN

The family pension scheme came into effect in our Bank from 01.01.1986 and fundamentally the State Bank of India Employees' Family Pension Rules and Procedures were framed by adopting the CCS (Pension) Rules, 1972.

- 2. Some of the amendments in Family Pension Rules and Procedures were subsequently made by the Bank in tune with the amendments brought in the CCS (Pension) Rules, 1972 by the Government. Few references of such amendments are (i) Eligibility of family pension to the widower, (ii) order of age of children for eligibility of family pension, (iii) Family pension to the eligible beneficiaries where the beneficiaries are twin children, (iv)inclusion ofparents as beneficiaries thereby widening of the scope of family for family pension, (v) disability certificate to be obtained from a Medical Officer not below the rank of a Civil Surgeon, etc.
- 3. The provisions in Family Pension Scheme under SBI Employees Pension Fund regarding eligibility of payment of family pension to the disabled children are as under:
  - a) The guidelines as contained in Hyderabad Circle Circular No. PER/11/95-96 dated 23.09.1995 (Copy enclosed) stipulate that "only that disability which manifests itself in the child before retirement or death of the employee while in service shall be taken into account".
  - b) The bank had also enabled the provision of nomination of members of the family including disabled children for the benefit of family pension before retirement of the employee vide e-Circular No.CDO/ P&HRD-PPFG/16/2012-13 dated26.05.2012 (Copy enclosed).
- 4. Regarding Nomination, the provisions under CCS (Pension) Rules, 1972, as contained in "A Handbook on Family Pension" (copy enclosed) are reproduced hereunder:
  - a) The employee has no control over the family pension as he is not required to make any contribution to it. It is not a property of the deceased employee/pensioner, therefore the entitlement for family pension cannot be decided by succession certificate;
  - b) The rules do not provide for any nomination, instead it designates the persons who are entitled to receive family pension. Thus, no other person except those designated under the rules is entitled to receive family pension.
  - c) The non-applicability of nomination for payment of family pension as above has arisen on account of several court judgements. One such judgement of the Hon'ble Supreme Court in the case of Smt. Violet Isaac and Ors. vs Union of India &Ors. is enclosed for your instant reference and perusal.
- 5. Regarding eligibility of Family Pension to disabled children, the provisions in the CCS (Pension) Rules, 1972 (Copies enclosed) are as under:
  - a) Sub Rule (7)(1) of Rule-54: Procedure for payment of family pension to handicapped children.
     Under O.M. No. 1/80/89-P. & P.W. (C), dated the 19th February, 1990 (not printed) the condition of manifestation of the disability of children before retirement or death in harness of the Government servant for grant of family pension for life has been dispensed with.

- b) O.M. No.1/21/91-P&PW(E)(Pt.) dated15.01.1999: Procedure for payment of Family Pension to handicapped children: It has been decided to allow the spouse of the deceased pensioner/ Government servant, if the details of such children were not furnished by the latter, to furnish the details of eligible children to the pension sanctioning authority.
- c) DOP&PW'sO.M. No.1/33/2012-P&PW(E) dated 16.01.2013: The Government has decided to allow continuance of family pension to mentally/physically disabled children even after their marriage.
- d) DOP&PW's O.M. No.1/18/2001-P&PW dated 25/26.01.2016: Non-intimation of physical/mental handicap does not make a child ineligible for family pension. A disability certificate issued after the death of the employee/ pensioner or his/ her spouse for a disability which existed before their death may be accepted by the Appointing Authority.
- 6. It can be observed from the above that the rules stipulated by the Bank regarding eligibility of payment of family pension to the disabled children, were based on the provisions under the CCS (Pension) Rules, 1972 at the material time of formulating the scheme, whereas the subsequent amendment referred above under para-5(a) has not been given the effect. Resultantly, the payment of family pension to the disabled children of employees, where the disability has been manifested after retirement/death of the employee while in service, is being denied.
- 7. It will not be out of context to mention here that the spouse of the employee, who gets married to the employee after his/her retirement is eligible for payment of family pension, even though the circular under reference in para-3(b) above stipulates nomination for spouse too, before retirement of the employee. While it is so, we are of the view that even those children whose disability has manifested after retirement/death of the employee/pensioner/family pensioner and rendered them unable to earn a living, shall be made eligible for grant of family pension, as provided under CCS (Pension) Rules.
- 8. In view of the above and considering the negligible number of cases in this category of disabled children and keeping in view the special needs of such a child/sibling, who requires greater medical care and financial assistance, we request you to arrange for review of the provisions for payment of family pension to the disabled children for lifetime in tune with the provisions stipulated under CCS (Pension) Rules, 1972 as under:
  - a) The condition of manifestation of the disability of children before retirement or death of the employee while in service needs to be dispensed with;
  - b) A disability certificate issued after the death of the employee/pensioner or his/her spouse for a disability which existed before their death shall be accepted for payment of family pension to the disabled children:
  - c) Continuance of payment of family pension to the mentally/physically disabled children even after their marriage.
- 9. We request that our representation is taken up with the appropriate authority at Corporate Centre along with your recommendations towards resolution of the issue at the earliest. Please advise us the developments in this regard..

## PENSIONERS' GENERAL MEETING

The Pensioners' General Meeting was conducted, as scheduled, on 26.06.2023 in the Meeting Hall of SBIOA Guest House, Narayanguda, Hyderabad. The meeting was attended by around 80 members thereby filling the entire hall.

After invitation of office-bearers to the dais by Shri P. Bhaskara Rao, DGS (HQ), the meeting commenced on time.

Shri N. Radhakrishnan, President in his initial remarks stressed on the imperative need for co-ordination between the Pensioners' Association and the serving employees Union and Association. He further said that there exists a very good co-ordination between the Pensioners' Association and the serving employees' organisations. President also thanked Com. R. Sriram, General Secretary, SBI Staff Union Hyderabad Circle for his gracious presence in the meeting despite his busy schedule and Shri Sai Prasad, General Secretary, SBI Officers' Association (Hyderabad Circle) for providing the Hall for the meeting of Association at free of cost.

Com. R. Sriram also reiterated the need for co-ordination between the Pensioners' Association and the serving employees' organisations and said that the Union as well as Officers' Association in the Circle are also doing their best in the resolution of issues of Pensioners by representing at the appropriate level with the circle management. He also quoted the efforts of serving employees in the issue of sanction of additional stagnation increment and revision of pension. Com. Sriram categorically conveyed that these three organisations should co-ordinate and take up the issue of 100% neutralisation of Dearness Relief to pre-01.05,2005 retirees

and updation of pension for all pensioners and achieve success, which will benefit the entire pensioners community. He also assured his total support to all the initiatives of the Pensioners' Association in all its endeavours.

Shri Ramesh Babu, General Secretary thanked Com. Sriram and Shri Sai Prasad for all the support that is being extended and said that the meeting assumes significance because the meeting is the first meeting after taking over of the administration of the Association by the newly elected office-bearers. Shri Ramesh Babu then requested the members to come forward and express the problems faced by them, raise queries, seek clarifications, etc. and said that the President and General Secretary would respond thereafter.

S/Shri SVSS Murthy, RS Murthy, Ch. Narendar, Sita Rama Rao, Krishna Rao, P Ram Mahohar, Shri Raja Rao, GSV Subba Rao, Anjaneya Reddy and Mohd. Yunus participated in the deliberations and raised various issues, presented their views and suggestions. The issues referred by the above members include Insurance e-cards pending corrections, problems in Medibuddy App, grant of additional stagnation increment, etc.

The suggestions include revision of ceilings on treatment of certain diseases under Insurance, consideration of last drawn salary for pensionary benefits as is provided to Central/State Government employees, Twoway communication system in official Whatsapp Groups, starting of Website, inclusion of Mammography and other cancer related tests in the list of approved diagnostic tests, lobbying for improvements in pension, establishment of Bank's dispensaries at various main centres of Hyderabad City, Insurance premium to be

borne by the bank, establishment of Retiree Home, applicability of revised Gratuity rules to bank employees, amended pension sanction advice containing simultaneous sanction of revised family pension, retaining the Association's own building without selling as it is located at a prime place and so on.

Shri Ramesh Babu, General Secretary in his responses explained the necessity of selling the RTC 'X' Road premises of Association that was approved by the AGM and the arrangement of continuing the availability of Doctors in RTC 'X' Road premises in the existing pattern till the sale of the premises. General Secretary further explained the details of Court case and subsequent developments like constitution of DoFS Committee and provision of submission of memorandum to the Committee and conveved that the Circle Association sent various suggestions on issues for inclusion in the Memorandum to be submitted by the FSBIPAs. On ceilings fixed under Medical Insurance Scheme, General Secretary said that the issue would be referred to FSBIPAs for further follow-up with Corporate Centre. On establishment of Retiree Home, General Secretary categorically informed that it is not feasible/practicable.

Shri Radhakrishnan, President later spoke on various issues such as the demand for establishment of diagnostic centres in all District Head Quarters Centres, procedure relating to procurement/stock of medicines, the efforts made by the Association in smooth process of renewal/enrolment of insurance, corrections relating to insurance e-cards, representation of issues relating Medibuddy at Circle level as well as FSBIPAs level.

President informed that efforts are being made to create an exclusive Website for the

Association and said that the official Whatsapp Groups created are for providing instant and faster information to members and members also have an avenue to represent their problems through Whatsapp by messaging to the Admins of the respective Groups where the President, General Secretary, DGS (HQ) and the Group-in-charge are the Admins.

President also spoke on various problems confronting the pensioners in the areas of settlement of medical bills by insurance company and the suggestion of the Association for reconstitution of Rejection Review Committee, stagnation increment issues relating revision of pension with the notional effect as provided under 10th and 11th BPS/Joint Notes and the efforts of the Association with the Circle Management on these issues.

President further explained about the developments relating Court Case of FSBIPAs on pension issues, the role of Association in the suggestions on essential amendments to Family Pension Rules Visà-vis Government Pension Rules and informed that the Association would vigorously pursue with the circle management as well as FSBIPAs for eventual follow-up with Corporate Centre on all the issues confronted by the Pensioners.

The President and General Secretary jointly appealed to all members to stay united and co-ordinate with the Association in the enrolment of membership towards strengthening the Association. Shri Ramesh Babu, General Secretary conveyed that members can represent their issues/problems to any office-bearer of the Association either by visiting Association Office or by messaging through Whatsapp and assured that every effort would be made

towards resolution of the issues at the earliest. General Secretary appealed to all the members present thereat, to contribute Rs. 300/- towards AGM to be held in Dec.23/ Jan. 24. An amount of Rs. 10,600/- has been collected.

Shri Mohan Rao, Treasurer proposed Vote of Thanks and the meeting ended with rendering of National Anthem.

## "SBI SALUTE" PAYMENT OF EX-GRATIA TO 75 YEARS & ABOVE STAFF PENSIONERS AND FAMILY PENSIONERS AS A PART OF "AZADI KA AMRIT MAHOTSAV" AND CELEBRATION OF 75 YEARS OF INDIAN INDEPENDENCE

India is celebrating "Azadi ka Amrit Mahotsav" – 75 years of independence of India. As we celebrate this landmark occasion, it is the time to acknowledge the contributions of aged retirees and convey our gratitude towards their exceptional work, professionalism and commitment during the period of service in the Bank.

- 2. In view of the above, the Central Board in its meeting held on 21st June 2023, has approved the payment of **one-time** Ex-Gratia amount under "**SBI SALUTE**" to staff pensioners and family pensioners, who have completed / will be completing 75 years of age as on 31st August 2023. The payment of ex-gratia to our old age retirees is the part of celebration of "Azadi ka Amrit Mahotsav" as well as Bank's performance during financial year 2022-23.
- 3. The salient features of "SBI SALUTE" for the payment of Ex-gratia are as under:
  - i. All Staff Pensioners / Family Pensioners of IBI/SBI/e-ABs who have completed/ will be completing 75 years of age as on 31st August 2023 are considered eligible under "SBI SALUTE".
  - ii. Eligible Staff Pensioners / Family Pensioners are divided into 3 categories based on completed years of age i.e., 75 to 79 years of age, 80 to 89 years of age and 90 years & above.
  - iii. The amount of Ex-Gratia is based on Scale / Grade of the pensioners at the time of retirement from the Bank service.
  - iv. The ratio of Ex-Gratia payment to the Staff Pensioners and Family Pensioners in the same age bracket would be in 50:30 ratio.
  - v. Applicable tax on the payment of Ex-Gratia will be borne by the beneficiary and shall be deducted at source.
  - vi. Payment will be made in Branches, starting with the Staff Pensioners/ Family Pensioners, who have completed 75 years of age as on 30th June 2023. Staff Pensioners/ Family Pensioners completing 75 years of age as on 31st August 2023 will be pa ssssid on or after 01st September 2023.
  - vii. The payment of proposed Ex-Gratia will be made centrally through HRMS only.
  - viii. The **ONE-TIME** payment of Ex-gratia under "**SBI SALUTE**" shall not be considered as part of any retiral benefit.
- 4. DMD (HR) & CDO has been authorised to issue any clarification and guideline in the related matter.

**NOTE:** Eligible members, who have not received the ex-gratia or received less than their eligibility, shall escalate the matter to PPG Department, with a copy marked to us, for further follow-up at our end.

#### Re:- E-PHARMACY

With due respect we like to draw your kind attention to our letter no 01/23 dated the 4th April 2023 on the captioned subject.

We are sorry to inform you that even after a lapse of more than 3(three) months from the commencement of the scheme both vendors are not supplying "Insulin" or any refrigerated medicines PAN INDIA. They are also not supplying all medicines, as prescribed by the attending physicians of the pensioners at large. We are given to understand that one vendor is supplying medicines through the erstwhile vendor i.e. Apollo Pharmacy in some places, some medicines are not being supplied on the plea that it has been directed by the Bank not to supply, some vendors are not extending discounts on agreed rate for all prescribed medicines. We are also sorry to submit that the instances of partial and delayed delivery of medicines are at galore. Pensioners are being denied the facility, which the Bank has extended very generously to the retired seniors employees. We are not being informed neither by the vendor nor by the Bank, but we as an organisation are being blamed by the eligible pensioners of SBI all over the country.

In view of the above prevailing overall dismal situation we would request you to kindly give us an appointment, at your earliest, to enable us to explain to you the tragic situation and also sufferings of the pensioners and also to discuss how to overcome and redress the present problem of the pensioners.

#### CONSTITUTION OF A COMMITTEE ON PENSION MATTERS OF STATE BANK OF INDIA

It has come to our notice that the Govt. has constituted a Committee with the approval of Hon'ble Finance Minister comprising of few members as referred in the communication, for making suggestions on the pension issues of SBI for making improvement in Pension Scheme for its retirees.

- 2. The letter mentions the Terms of reference of the Committee which are as under :
  - i) to examine/review the extant concept of payment of pension at the rates of 50% and 40%;
  - ii) to examine the suggestions of retirees for payment of pension at the rates of 1160th for every completed year of pensionable service as provided in Rule 23(1) of SBI Pension Regulation;
  - iii) To examine the issue of neutralization of Dearness Allowance (DA) on pension for those who retired before 01.05.2005.
  - iv) to examine the issue of updation of pension with every wage revision/ settlement.
  - v) to suggest the course of action, while balancing the cost of retiral benefits and the financial implication on the bank.

The Committee may also take into consideration the retiral/other benefits as available in Nationalized Banks and possible industry vides ramifications, while examining the above issues.

- 3. In this regard the Former Council Members of All India State Bank of India Staff Federation, which is the highest body of the Former Office Bearers/Council Members of All India State Bank of India Staff Federation, has prepared a memorandum and send it to us and have requested us to kindly take up the matters appropriately with the authorities concern at SBI, Corporate Centre, so that the issues can be taken to the logical end by the bank management while they appear before the DoFS Committee, to present the views of the Bank on pension related issues. The copy of Memorandum is enclosed herewith for your ready references.
- 4. Besides this The All India State Bank of India Staff Federation has many other suggestions which have cropped in, such as payment of pension on the basis of Last Drawn salary instead of the average of 12 months' salary, payment of Extra pension as is being paid by the Govt. of India to the aged pensioners such that above 80 years, above 90 years, above 100 years of the age and so on. In this regard we have already written so many letters to the Bank giving many more suggestions.
- 5. So we request your good self to give us an opportunity to explain our view points on pension matters which we have received through our members/office bearers etc. and communicated to your good self. We hope that the opportunity will be given to us to explain our view points and in the meantime you will take the cognizance of the enclosed Memorandum submitted by the Former Office Bearers of All India State Bank of India Staff Federation and take up the issues with the Committee so that these issues can be taken to the logical end..

He further observed that this vendor does not have any outlets and functions like Amazon trading Company, OLA auto/Zomato. And is not yet all user friendly.

Establishment of Dispensary at Amalapuram centre Members felt the need of establishing a Dispensary at Amalapuram branch to cater to the needs of staff and pensioners

of Amalapuram region, who will be about 500. And this demand is pending for the past 5 years. Shri Satyanarayana advised members that the Association is vigorously following it up with the Circle management and hoped that the same will be cleared soon. Meanwhile, he constituted a 5 member sub committee to search for suitable medical doctor at Amalapuram for consideration by RBO/AO.

#### Sanjeevani redressal portal

It is agreed upon by all the members that they may utilise the service of "Sanjeevani" (complaint lodging /redressal portal of HRMS). It will help the pensioners for quick reply/redressal of problems raised by them. Sanction of OD against Deposits to Staff pensioners.

Issue of sanction of OD at branches was also discussed. The branches are not sanctioning OD against Deposits to Public and staff pensioners showing some pretext or other. And members feel helpless. Shri Satyanarayana advised members that the matter will be brought to the notice of RBO for redressal.

#### **Swayam Passbook Printing Machine**

Swayam machines many times are not working or if worked, due to low quality / worn out ribbon, the entries cannot be readable. This has been causing hardships to our members who are forced to stand in queues for pass book printing in the hot sun.

There is no pass book printing machine provided at the Branch.

The convenor, Sri Satyanarayana assured members to bring the deplorable position to the Branch/ RBO authorities for redressal.

Thereafter, the meeting has been concluded.
