SBI STAFF PENSIONERS / FAMILY PENSIONERS - IDENTITY CARDS

The Staff pensioners / Family pensioners are issued Identity cards (as per standardised format) by the Bank in order to bring uniformity for all the identity cards issued before / after June 2020. Hence, all Pensioners / Family Pensioners are requested to approach his/her respective Pension Paying Branch for generation / issuance of standardised Identity Card.

What Pensioners need to do, on their own, to get their Identity Cards?

1. Login SBI HRMS with user name and password.
2. Click on Box “Pensioner Dependent – Additional Details”
3. Check available data under Employee Details such as PF Index, Name, Pension Paying Branch, Designation (at Retirement), Date of Birth, Date of Retirement, Blood Group.
4. Update Details of Pensioner’s Spouse/Special Child (where applicable) under Dependent Details.

Note: In case of corrections or non-availability of details of spouse/Special Child in HRMS, Pensioners need to approach Pension Paying Branch / PPG Department at LHO with copies of identity proof, address proof like Aadhaar Card, Pan Card, etc., to get the details updated.

5. If dependent details are available, Pensioner needs to Select name and Date of Birth and upload. Other details of spouse / special child such as Blood Group, Mobile Number, Aadhaar Number, Pan Number, Mail ID (where applicable) need to be updated particularly mandatory fields such as Blood Group of spouse/special child, Mobile Number & Mail ID of spouse.
6. Lastly, the Pensioner must upload the joint photograph with the spouse and wherever applicable, joint photograph with the Special Child. The size of Photograph of Pensioner with Spouse / Special Child should be 2x4 cm & should not exceed 50 kb.
7. After uploading of all required details, the authorised official in the Pension Paying Branch would approve the same.
8. After approval, the PPG Department will generate ID cards where all required details are fetched and would arrange for delivery of the printed ID cards to the Pensioner either by hand or by post to the communication address recorded in HRMS.

Note: Two ID cards would be generated - one bearing the joint photograph of the pensioner with the spouse and the other bearing the joint photograph of the pensioner / family pensioner with the special child (wherever applicable).

The pensioner himself/herself can update the details (where permissible) and upload the joint photographs. Alternatively, the pensioner can approach Pension Paying Branch to get the details updated through the branch.

In case of difficulty/assistance, members are requested to approach the Head Quarter office-bearers of SBI Pensioners Association Hyderabad Circle either personally in the premises at SBI Buildings, Koti, Hyderabad-500 095 or over phone.

The Bank has been providing several services and benefits to the staff pensioners and family pensioners. These services act as welfare measures and aim to create a better user experience for our senior colleagues. A robust Grievance Redressal Mechanism in form of "Sanjeevani HR Helpline" has also been put in place for taking care of all issues of staff pensioners & family pensioners. In order to propagate a culture of Quick Grievance Redressal for our staff pensioners' retirees and to develop uniformity in redressal process, it has been decided by the competent authority to observe "Samadhan Pakhwada" (Pensioners' Grievance Redressal Fortnight) from 08th May 2023 to 20th May 2023.

In this connection, we request you to arrange as under :

1. Expeditious resolution of all grievances pending as on date.
2. Resolve all grievances lodged by the pensioners / family pensioners during the fortnight to be resolved within the fortnight.
3. Ensure to lodge all complaints / grievances received through emails, letters, SMSs in Sanjeevani Portal by Circle HR / PPG Department.
4. Ensure that the grievances are lodged under relevant category / sub-category.
5. Assignment of responsibility to resolve grievances as below :

Subject: Constitution of a Committee on pension matters of State Bank of India-regarding.

The Government has decided to constitute a Committee with the approval of Hon'ble Finance Minister comprising of the following, for making suggestions on the pension issues of SBI for making improvement in Pension Scheme of its retirees:

2. The Terms of Reference of the committee is as under:

- (i) to examine/review the extant concept of payment of pension at the rates of 50% and 40%.
- (ii) to examine the suggestions of retirees for payment of pension at the rate of 1/60th for every completed year of pensionable service as provided in Rule 23(1) of SBI Pension Regulations;
- (iii) to examine the issue of neutralization of Dearness Allowance (DA) on pension for those who retired before 01.05.2005;
- (iv) to examine the issue of updation of pension with every wage revision/settlement;
- (v) to suggest the course of action, while balancing the cost of retiral benefits and the financial implication on the bank.

The committee may also take into consideration the retiral/other benefits as available in Nationalised Banks and possible industry wide ramifications, while examining the above issues.

3. The Committee is requested to give its recommendations on the above issue on or before 21.7.2023 and the Committee shall set its own procedure for regulating its work.

4. The necessary secretarial, logistic and other assistance to the Committee shall be provided by State Bank of India.

DEDUCTION OF COMMUTATION AMOUNT AVAILED BY THE PENSIONER FROM OUT OF FAMILY PENSION AT FULL RATE

An employee who retires from the Bank's service on or after 01.01.1986, shall be entitled to commute upto, a lumpsum payment of, a fraction not exceeding one-third of his pension with effect from 01.11.1994 or on any subsequent date, from which he becomes eligible for commutation.

2. The commuted admissible portion of pension, as above, shall be restored after the expiry of a period of fifteen years from the date of commutation. In other words, the recovery relating to the portion of commuted amount availed by the pensioner is made from the eligible monthly pension payable to him/her for a period of fifteen years.

3. In terms of the existing instructions, the family of a pensioner is eligible, in case of death of a pensioner before expiry of five years of retirement, for family pension at full rate of normal pension, for the balance period upto five of retirement, provided the employee had completed the required pensionable service on the date of his/her death/retirement.

4. However, in respect of the above eligible cases, where the family pension needs to be disbursed at full rate, the portion of commuted amount is being deducted from out of family pension payable to the family pensioner, which is not correct for the following reasons:

- a) The instructions for payment of family pension at full rate or normal pension relates to the eligible gross pension of the pensioner;
- b) Deduction of commutation amount availed by the pensioner from out of family pension payable to the family pensioner is against the Law.

5. In this regard, we inform that even in respect of similarly placed family pensioners of Government employees, the portion of commutation amount is not deducted from the family pension and the relevant clarification issued by the Department of Pension & Pensioners Welfare, Government of India vide O.M. No.42/15/2022-P&PW(d)/5 dated 25.10.2022 is enclosed for your instant reference and perusal.

6. In view of the above, we request you to arrange for issuance of similar instructions by the bank clarifying that the monthly commuted amount of pension is not required to be deducted from family pension and family pension shall be paid in full without any deduction in this regard.

7. We request that our representation is taken up with the appropriate authority at Corporate Centre along with your recommendations towards resolution of the issue at the earliest. Please advise us the developments in this regard.

PROVISION OF FAMILY PENSION TO WIDOWED / DIVORCED / DESERTED DAUGHTER OF PENSIONER / FAMILY PENSIONER

The Family Pension Scheme in our Bank provides for grant of family pension to the unmarried daughter of the employee until she attains the age of 25 years, or until she gets married, or is gainfully employed, whichever is earlier.

2. The above provision was made at the time of introduction of the Scheme effective from 01.01.1986, in tune with the provisions under CCS (Pension) Rules, 1972 at the material time.

3. While revising the provision regulating pension as per Government's decision on the recommendation of the Fifth Central Pay Commission, the following amendment was provided vide clause (b) of Para 7.2 of Department of Pension and Pensioners Welfare Office Memorandum F.No.45/86/97-P&PW(A)-Part-I dated 27.10.1997, a copy of which is enclosed for your instant reference:

"For the purpose of grant of Family Pension, the definition of 'Family' shall also include Son/ Daughter including widowed/divorced daughter till he/she attains the age of 25 years or upto the date of his/her marriage/remarriage, whichever is earlier"

4. Subsequently, the Department of Pension and Pensioners Welfare, on receipt of several representations and in consultation with the Ministry of Finance, Department of Expenditure and Ministry of Law and Justice, Department of Legal Affairs, etc., vide its O.M. No.1/19/03-P&PW (E) dated 30.08.2004 (Copy enclosed), decided that there will be no age restriction in the case of the divorced/widowed daughter who shall be eligible for family pension even after attaining 25 years of age subject all other conditions prescribed in the case of son/daughter.

5. It was further clarified by the Department of Pension & Pensioners Welfare vide its O.M. No.1/13/09-P&PW (E) dated 11.09.2013 that family pension to a widowed/divorced daughter is payable provided she fulfils all eligibility conditions at the time of death/ineligibility of her parents and on the date her turn to receive family pension comes. (Copy enclosed)

6. It will not be out of context to mention here that in our Bank, the dependent widowed/divorced/separated daughters are considered as members of family for the facilities of LFC and Medical reimbursement in terms of provisions under Bipartite Settlements.

7. In view of the above, considering the needs of the dependent widowed/divorced/separated daughters for their survival, we request that grant of family pension to the widowed/divorced/separated daughters be considered by the Bank in tune with the amendments brought by the Government in the CCS (Pension) Rules as mentioned under paras-3 to 5 above.

8. We request that our representation is taken up with the appropriate authority at Corporate Centre along with your recommendations towards resolution of the issue at the earliest. Please advise us the developments in this regard.

With reference to the above, we advise that the indicative FORM NO.16 (PART-B) & FORM NO. 12BA for the Financial Year (FY) 2022-23 has been made available through HRMS Portal as mentioned below:-

- A. For active employees (including contractual employees) posted at Branch/Office: -
 - In HRMS Portal of BMs/Authorized Officers & 4-in-1 Approvers of the Branch/Office where the employee was posted as on 31.03.2023, under the path **Manager Approvals → Earnings/Salary Tile → Form 16 Part- B/Form 12BA Tile → Form 16 Part-B & Form No. 12BA.**
- B. For the employees who have been posted to foreign offices during the FY 2022-23:-
 - In HRMS Portal of BMs/Authorized Officers & 4-in-1 Approvers of the Branch/Office from where the employee had drawn his/her last Indian salary, under the path **Manager Approvals → Earnings/Salary Tile → Form 16 Part-B/Form 12BA Tile → Form 16 Part-B & Form No. 12BA.**
- C. For the employees for whom the payment was made till the date of retirement during the FY 2022-23 (other than pensioners):-
 - In HRMS Portal of BMs/Authorized Officers & 4-in-1 Approvers of the Branch/Office from where the employee had drawn his/her last salary, under the path **Manager Approvals → Earnings/Salary Tile → Form 16 Part-B/Form 12BA Tile → Form 16 Part-B & Form No. 12BA.**
- D. For Pensioners (including e-ABs Pensioners)
 - In HRMS Portal of BMs/Authorized Officers of pension disbursing branch for March 2022 under the path **Manager Approvals → PF/Pension/PF/Gratuity Tile → Form 16 for Pensioners Tile → Form No. 12BA & Form 16 Part-B.**

2. In this connection, we refer to e-Circular No. CDO/P&HRD-PM/70/2022-23 dated 1st February 2023 and request you to arrange to inform all the **DDOs (i.e. Branch/Office/OAD Heads)** of your Circle/Payroll to ensure that **FORM NO.16 & FORM NO. 12BA** is made available to all those employees who were posted at the Branch/Office as on 31st March 2023 and to the employee(s) who were retired/resigned (other than pensioners) or posted to foreign office during the FY 2022-23 and had drawn his/her/their last salary from that Branch/Office/OAD. Please also inform all the DDOs of pension paying branch to ensure that **FORM NO.16 & FORM NO. 12BA** is also made available to the pensioners who have drawn the pension for the month of March 2023 from their branch. **FORM NO. 12BA** is to be issued to the pensioners who retired during the FY 2022-23.

3. While issuing the **FORM NO.16 (PART-B)** the DDOs should ensure that **FORM NO.16** is issued to the employees/pensioners after due authentication and verification of the details of both Part of the **FORM NO.16 (i.e. PART A & B)** in accordance with the provisions of section 203 of the Income Tax Act, 1961 & Circulars issued by Income Tax Department from time to time. **The PART-A of the FORM NO.16 is digitally signed by the authorised officer of FRT Department, CC, Mumbai and PART-B is digitally signed by the nominated officer of HRMS Department, GITC, Navi Mumbai. The FORM NO. 12BA is to be**

signed by the DDOs before issuing to the employees/pensioners. Please also advise the DDOs to ensure compliance of the instructions given in the e-Circular No. CDO/P&HRD-PM/70/2022-23 dated 1st February 2023. The DDOs should issue the FORM NO.16 after validating the digital signatures. Manual for validating digital signature is annexed and the same is also available in HRMS Portal. Further, copy of this letter is also available in HRMS Portal.

4. As per CBDT Circular No. 20/2020 [F.No. 275/192/2020-IT(B)] dated 03.12.2020, PART-A of the FORM NO.16 which is a statement of Income Tax deducted by the employer from the salary/pension of the employee/pensioner, is generated centrally by the FRT Department, CC, Mumbai and made available by them in Branch Folder as well as through CBS in TAX CPC App. Further, PART-A of the FORM NO.16 has also been made available by us in HRMS Portal of individual employee/pensioner.

5. In addition to above, the Circle/Payroll HRMS Teams have been given rights of T-Code **ZPC00_M40_F16N (for employees)** to download the FORM NO. 12BA for the FY 2022-23 for employees of their Circle/Payroll by using the **Variant - FORM12BA_22-23**. Further, Circle PPG Teams have been given rights of T-Code **ZPC00_M40_F16P (for pensioners)** to download the FORM NO. 12BA for the FY 2022-23 for pensioners of their Circle by using the **Variant - FORM12BA_22-23**. Hence, in case, any of the DDO faces a difficulty in downloading FORM NO. 12BA through HRMS Portal, then the HRMS/PPG Teams should provide the same to the DDO after downloading from SAP.

The Circle/Payroll HRMS Teams (for employees) & Circle PPG Teams (for pensioners) will ensure to take a data dump of the FORM NO. 12BA in PDF format, for future use because, at a later date the retro accounting may alter the FORM NO. 12BA available in the HRMS system. Manual for downloading FORM NO. 12BA in bulk is attached.

6. As issuance of FORM NO.16 is a statutory requirement for the employer and it has to be issued within the stipulated time, therefore please instruct the DDOs (i.e. Branch/Office/OAD Heads) to download the FORM NO.16 (PART-B) and FORM NO. 12BA from HRMS Portal and to issue to the employees/pensioners of their Branch/Office and to the employee(s) who were retired/resigned (other than pensioners) or posted to foreign office during the FY 2022-23 and had drawn his/her/their last salary form that Branch/Office/OAD. **It is pertinent to mention here that PART-A & PART-B of FORM NO.16 downloaded from the TRACES Site should only be issued to the employees/pensioners because, only the FORM NO.16 downloaded from the TRACES Site are valid. Hence, any manual correction should not be done in these forms.** The details of any payment made manually outside HRMS and not updated in the HRMS System before final processing of salary/pension for the month of March 2023, should be advised to the HRMS Department, GITC as per the procedure given in the attached SOP for filing of correction statements with Income Tax Department so that revised FORM NO.16 can be generated through TRACES Site for providing to the concerned employee/pensioner.

7. Under the Rule 26C read with section 192 (2D) of the Income Tax Act obtaining a declaration under FORM NO.12BB from employees/pensioners is a mandatory requirement. **Hence, please instruct the DDOs to obtain declaration in the prescribed FORM NO.12BB from the concerned employee/pensioner along with evidence/proof/particulars of claims for exemption of Income Tax made by them under different heads of Income Tax Act/Rules.**

Further, as per section 192 (2D) read with the rule 26C, it is mandatory for the DDOs to obtain details/evidence in respect of claim of exemption for leave travel concession or assistance before allowing the said exemption. The relevant form for furnishing details by employee is FORM NO.12BB. **Furthermore, the**

DDO must mention foreign LTC/HTC bill paid as income of the employee and tax amount if any deducted on it in Note No. 5 of the FORM NO. 12BA.

8. Please also instruct the DDOs to verify the details declared in the Investment Declaration Form (IDF) by the individual employee and to obtain evidence of declared investments by him/her before issuing PART-B of FORM NO.16 (digitally signed by the nominated officer of HRMS Department, GITC, Navi Mumbai) & FORM NO.12BA (to be signed by the DDO of the respective Branch/Office/OAD) to him/her. **The DDOs must maintain proper record of digitally signed office copy of the FORM NO.16 and duly signed FORM NO. 12BA for future requirement if any.**

9. The employees/pensioners who have not claimed any exemption/deductions against any investment may be provided copy of the FORM NO.16 & FORM NO.12BA, through their given e-mail ID as per their request. Further, if any employee/pensioner is willing to submit scanned copies of IDF, FORM NO.12BB and proof of investments through mail then, copy of the FORM NO.16 & FORM NO.12BA may be provided to them after due authentication of scanned copies of IDF, FORM NO.12BB and proof of investments by the DDO.

10. Although FORM NO.16 (PART-B) is digitally signed by the nominated officer of HRMS Department, GITC, Navi Mumbai, the DDOs (i.e. Branch/Office/OAD Heads) are overall responsible for Salary & Income Tax related matters of the employees who have drawn salary and perquisites from their Branch/Office/OAD in terms of the Bank's extant instructions and also given in the e-Circular No. CDO/P&HRD-PM/70/2022-23 dated 1st February 2023.

- a proposal to cancel e-pharmacy benefits and reduce premium on Health Insurance irrespective of age of the pensioner.
- Request for opening of dispensaries and tie up of diagnostic centres at more places and appointment of specialist doctors in dispensaries and inclusion of CT/MRI scan in approved tests is being made to the Bank management.
- It is desirable PPF & G Dept., have a dedicated cell to counsel/advise individual pensioners who approach directly instead of their grievance being referred by units of Association to expedite redressal of pensioner grievances.
- Transfer of pension files of Amaravati Circle pensioners from Hyderabad Circle needs to be expedited to avoid delays.
- Reimbursement of bills for viral fever etc. under MWS are returned informing not eligible. This should be avoided as many pensioners may not avail facilities of Bank dispensaries due to location disadvantages and emergencies in need.
- Demands for 100% DA neutralisation for pre 2002 retirees; removal of ceiling on pension (40%/50%), enhancement of pension prior to 1986 pensioners and inclusion of PQA/FPP for VII Bi-partite pensions are being actively followed up.

Shri W.Mallinatha Suri proposed vote of thanks. The meeting ended with a rendition of the National Anthem.

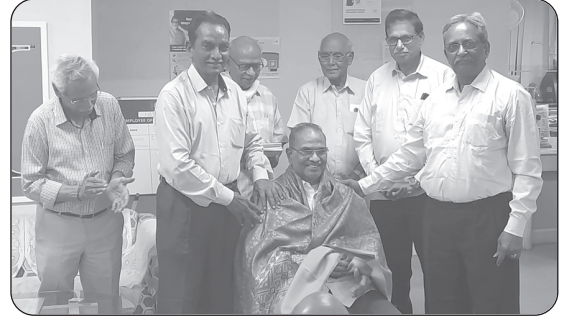
VIJAYAWADA UNIT
